Methadone: The good, the bad, and the ugly Alvin H. Moss, MD, FAAHPM and Michael G. O'Neil, PharmD

West Virginia physicians need to know the ugly about the use of methadone for pain management. In West Virginia between 2001 and 2006, the number of unintentional drug overdoses associated with methadone resulting in death increased sixfold. (1) Between 1999 and 2004 the percentage change in unintentional poisoning mortality rate (most poisoning deaths are due to drug overdoses) was higher in West Virginia, 550%, than in any other state. (2) More patients dying of unintentional drug overdoses died from methadone overdose than any other medication. Clearly methadone should only be prescribed for those patients when other medications have not satisfactorily controlled their pain. For each patient prescribed a controlled substance, especially patients who are prescribed methadone, attention needs to be given to the possibility of drug abuse, diversion, and serious drug interactions.

The good is that methadone is increasingly being recognized as a useful alternative for the treatment of cancer pain and is effective in the treatment of both nociceptive and neuropathic pain. It blocks the N-methyl D-aspartate (NMDA) receptor-channel complex in the dorsum of the spinal cord and is a mu, kappa, and delta opioid receptor agonist. Methadone is also inexpensive, costing about one-tenth the amount of morphine. Because methadone has a long half life which increases the longer the medication is prescribed, methadone can be dosed at extended intervals (every 8 to 12 hours) for the treatment of chronic pain and for end-of-life care. Because methadone is metabolized by the liver and there are no renally excreted active metabolites, methadone is one of the safer opioids analgesics to use in patients with chronic kidney disease.

Methadone's bad properties include that it has a long and variable half life and that it has a large number of interactions with other medications. Conversion from other opioids to methadone can be challenging (there are several different approaches), and there is not a standard approach for converting from methadone to other opioids. Drug interactions with methadone may lead to an increase or decrease in methadone levels. Because of its long half life, if a physician over shoots on his or her initial dosing of methadone, patients may need to be treated with a naloxone continuous infusion until the patient wakes up from the central nervous system depressant effects of the methadone.

Physicians should not prescribe methadone for the treatment of chronic pain unless they are well versed in its pharmacokinetics, drug interactions, and conversion from other opioids analgesics. Physicians who want to prescribe methadone in their practice should obtain continuing medical education on its use.

REMINDER DATA 2000 - (SAMHSA/CSAT)

No more than ninety (90) M.D.'s throughout West Virginia at this time are authorized to use Schedule III, IV, or V opioid drugs for the maintenance and detoxification treatment of opioid addiction in accordance with Federal law. These ninety (90) M.D.'s are authorized to treat only a certain number of such patients, in accordance with the Notification of Intent (NOI) filed by the physician and then authorized in writing through the Center for Substance Abuse Treatment (CSAT). There is no authority for CSAT to grant any physician the authority to treat more than the patient limit set forth in law, up to thirty (30) initially, and after one (1) year, one hundred (100), if authorized in writing through CSAT. No physician in West Virginia has been granted the authority to treat more than one hundred (100) patients at one (1) time.

To avoid problems, it would be prudent for those of you engaged in this treatment to review and ensure your compliance with the authority you have been granted. ???DID YOU KNOW???

Are you thinking about being an Internet prescriber? Are you being recruited to review and sign off on prescriptions over the Internet? Be aware that the Board of Medicine Rule, 11 CSR 1A, at 12.2, specifies that the following is considered "dishonorable, unethical or unprofessional conduct of a character likely to deceive, defraud or harm the public or any member thereof":

k. A practice of providing treatment recommendations relating to issuing prescriptions, via electronic or other means, for persons without establishing an on-going physician-patient relationship wherein the physician has obtained information adequate to support the prescription: Provided, That this definition does not apply: in a documented emergency; or in an on-call or cross coverage situation; or where patient care is rendered in consultation with another physician who has an ongoing relationship with the patient, and who has agreed to supervise the patient's treatment, including use of any prescribed medications.

It might be of interest to you as well to look at what the National Clearinghouse on Internet Prescribing (NCIP) www.fsmb.org/ncip_overview.html is doing in collecting information on "rogue" Internet pharmacy websites offering prescribing and dispensing to consumers. NCIP has been functioning within the Federation of State Medical Boards for eight (8) years and its work has resulted in discipline of physicians across the country.

WV License No. 19291

<u>Board Conclusion</u>: Relating to presenting false statements in connection with an application for a license. <u>Board Action</u>: Granted ACTIVE status for his currently lapsed license to practice medicine and surgery in the State of West Virginia effective July 29, 2008. BOARD MEMBER PROFILE Joe E. Miller, LTCOL USMC (RET) MA

Mr. Miller is one of the three lay members on the Board of Medicine. He was appointed by Governor Joe Manchin III in October, 2007, and serves as a member of the Physician Assistant Committee and the Corporate Practice of Medicine Committee.

A Cum Laude B.S. graduate of Alderson-Broaddus College, Mr. Miller served for twenty years as a U.S. Marine Corps officer, with two tours of combat in the Republic of Vietnam. He retired as a Lieutenant Colonel in 1978, receiving the Meritorious Service Medal, a Bronze Star with Combat "V", two Navy Commendation Medals with Combat "V", a Joint Service Medal, and a Vietnam Cross of Gallantry. He graduated from the Executive Leadership Institute, National Society of Fund Raising Executives, then in 1993, became a Partner in SunAmerica Securities, Inc., and FICON Insurance Company, based in Charleston, where he was a General Securities Registered Representative (series 7) for SunAmerica Securities, Inc., and an Agent for Life, Accident and Health Insurance and Property and Casualty Insurance, as well as an Estate Planning Advisor. In 1997, he was appointed Commissioner of the Division of Motor Vehicles for the State of West Virginia, where he served for almost four years, retiring in 2001.

In 1956, Mr. Miller was a member of the NAIA All America Basketball Team, also winning the Liston Award, the highest NAIA Individual Award, and in 1995, he was inducted into the NAIA National Basketball Hall of Fame. In 1974, he was inducted into the West Virginia Sportswriters Hall of Fame.

Mr. Miller served a six-year term on the Board of Trustees of Alderson-Broaddus College, ending in 2006. He currently serves as Chairman and Commissioner of the Putnam County Public Service District. Other activities include Masonic Lodge, Veterans of Foreign Wars, American Legion, and the Alumni Council, Alderson-Broaddus College.
