# BOARD ACTIONS July 2012 - September 2012



#### BALI, AHMAD, M.D. – Charleston, WV (08/10/2012)

WV License No. 21044

<u>Board Conclusion</u>: Probable cause exists relating to unprofessional conduct including a departure from, or failing to conform to, the standards of acceptable and prevailing medical practice, and relating to failure to maintain an adequate medical record for each patient, and/or to keep such patient medical record for a minimum of three (3) years from the date of the last patient encounter.

<u>Board Action</u>: Dr. Bali is PUBLICLY REPRIMANDED. Within six (6) months of the entry of the Order, he shall successfully complete a continuing medical education (CME) course sponsored by Case Western Reserve University on the subject of medical record keeping and twenty (20) hours of CME courses regarding the work-up and performance of repair of hiatal hernias and anti-reflux procedures. Failure to comply with requirements will result in Dr. Bali's license to practice medicine being placed on inactive status.

#### DUFFY, TRESSIE M., M.D. - Martinsburg, WV (09/18/2012)

WV License No. 19978

<u>Board Action</u>: After the expiration of her medical license on June 30, 2012, as of September 18, 2012, Dr. Duffy's license is REINSTATED subject to the requirement that until November 30, 2012, Dr. Duffy shall undergo regular, individual psychological counseling by a mental health professional.

#### JACKSON, PAUL EDWARD, M.D. - Fort Gay, WV (09/10/2012)

WV License No. 22059

<u>Board Conclusion</u>: The West Virginia Board of Medicine REVOKED the license to practice medicine and surgery of Dr. Jackson due to unprofessional conduct and being unqualified to practice medicine and surgery in the State of West Virginia as a result of having his license being acted upon by the Texas Medical Board for unprofessional conduct.

<u>Board Action</u>: Dr. Jackson's license to practice medicine and surgery in the State of West Virginia is REVOKED, effective September 25, 2012, at 12:00 a.m. Within thirty (30) days of issuance of an invoice by the Board, Dr. Jackson shall pay to the Board the costs of the proceedings and all other costs of investigation and prosecution of this matter in an amount not to exceed ten thousand (\$10,000.00) dollars.

#### MUTO, DEIDRA FAWN, M.D. - Charleston, WV (07/27/2012)

#### WV License No. 21489

<u>Board Conclusion</u>: Probable cause may exist relating to unprofessional conduct and relating to the renewal of a license to practice medicine and surgery by making a false statement in connection with a licensure application regarding completion of continuing medical education (CME) requirements.

<u>Board Action</u>: Dr. Muto shall complete, and provide certification of her completion to the Board, within ninety (90) days of the entry of the Order, nineteen (19) hours of approved AMA Category I CME coursework. Dr. Muto shall pay a CIVIL FINE in the amount of one-hundred dollars (\$100.00) per credit hour, together with a one-time ADMINISTRATIVE FEE in the amount of one hundred dollars (\$100.00), for a total of two thousand dollars (\$2,000.00). In the event that Dr. Muto fails to comply with the requirements stated in the Consent Order, her license to practice medicine and surgery in the State of West Virginia shall be suspended effective immediately.

<u>REYNOLDS, LEONARD ANTHONY, D.P.M.</u> – Wellsburg, WV (08/09/2012)

#### WV License No. 00271

<u>Board Action</u>: The Board of Medicine took action against Dr. Reynolds by Order entered on January 13, 2012. Subsequently, an Order was entered on August 9, 2012, by the Brooke County Circuit Court, West Virginia. The Order reversed the January 13, 2012, Order and dismissed the disciplinary action taken by the Board against Dr. Reynolds.

SALANSKY, JESSICA BETH, M.D. – South Charleston, WV (08/09/2012)

WV License No. 24142

<u>Board Conclusion</u>: Probable cause may exist relating to unprofessional conduct and to the renewal of a license to practice medicine and surgery by making a false statement in connection with a licensure application regarding completion of two (2) hours of continuing medical education (CME).

<u>Board Action</u>: Dr. Salansky shall pay a CIVIL FINE in the amount of two hundred dollars (\$200.00) and an ADMIN-ISTRATIVE FEE of one hundred dollars (\$100.00). In the event that Dr. Salansky fails to comply with this requirement, her license to practice medicine and surgery in the State of West Virginia shall be suspended effective immediately.

#### SHAH, MAHENDRAKUMAR CHIMANLAL, M.D. - Point Pleasant, WV (09/10/2012)

#### WV License No. 13785

<u>Board Conclusion</u>: Probable cause exists to substantiate charges against Dr. Shah relating to dishonorable, unethical or unprofessional conduct of a character likely to deceive, defraud or harm the public relating to exercising influence within the patient-physician relationship for the purpose of engaging a patient in sexual activity; relating to prescribing a prescription drug other than in good faith and in a therapeutic manner in accordance with accepted medical standards and in the course of the physician's professional practice; relating to failing to keep written records justifying the course of treatment; relating to malpractice and the failure to practice medicine with that level of care, skill and treatment which is recognized by a reasonable, prudent, similar physician as being acceptable under similar conditions and circumstances, and relating to dishonorable, unethical or unprofessional conduct by prescribing controlled substances in such an amount that Dr. Shah knew or had reason to know, under the attendant circumstances, that the amounts prescribed were excessive under accepted and prevailing medical practice standards. Board Action: Effective August 31, 2012, at 12:01 a.m., Dr. Shah's license to practice medicine and surgery in

<u>Board Action</u>: Effective August 31, 2012, at 12:01 a.m., Dr. Shan's license to practice medicine and surgery in West Virginia, No. 13785, is SURRENDERED and his dispensing registration issued by the Board, No. 01689, is TERMINATED. Dr. Shah shall SURRENDER his drug enforcement registration certificate to the Drug Enforcement Administration and provide evidence to the Board of the same on or before August 31, 2012. Dr. Shah shall CLOSE and terminate his medical practice on or before August 31, 2012, at 12:01 a.m. Dr. Shah shall not apply to the Board for licensure in the future, and if he does, his application will be denied.

#### STATON, MICHELE DAWN, M.D. – Beckley, WV (08/09/12)

#### WV License No. 23359

<u>Board Conclusion</u>: Probable cause may exist relating to unprofessional conduct and to the renewal of a license to practice medicine and surgery by making a false statement in connection with a licensure application regarding completion of one (1) hour of continuing medical education (CME).

<u>Board Action</u>: Dr. Staton shall complete, and provide certification to the Board within ninety (90) days of the entry of the Order, one (1) hour of approved CME in end-of-life care including pain management. Dr. Staton shall pay a CIVIL FINE in the amount of one hundred dollars (\$100.00) and an ADMINISTRATIVE FEE of one hundred dollars (\$100.00). In the event that Dr. Staton fails to comply with these requirements, her license to practice medicine and surgery in the State of West Virginia shall be suspended effective immediately.

The \$10 search fee allowed by state law in West Virginia Code § 16-29-2(a) has been preempted and voided by HIPAA (the federal law known as the Health Insurance Portability and Accountability Act). The \$10 search fee may not be charged by health care providers when providing copies of medical records requested by patients.
