Rev. O. Richard Bowyer, MDiv, ThM of Fairmont, WV, received the Lifetime Achievement Award, bestowed upon him by the Federation of State Medical Boards at its Annual Conference on April 26, 2014, in Denver, Colorado. This is a unique award. bestowed infrequently as the Awards Committee deems appropriate and is not given on an annual basis.

The award was presented in recognition of Rev. Bowyer's leadership and contributions to the WV Board of Medicine over a span of almost 30 years and in testimony to the greater calling held by this man. Seven different Governors, beginning with current U.S. Senator John D. Rockefeller, IV, and most recently Governor Earl Ray Tomblin, have appointed Rev. Bowyer to the West Virginia Board of Medicine. He currently holds the office of president of the Board of Medicine, the first public member ever elected to this office in its 131-year history.

A life-long resident of West Virginia, Reverend Bowyer graduated with honors from Marshall University and obtained a Masters of Divinity and Masters of Theology from Duke University in North Carolina. He retired as Campus Minister for the Wesley Foundation at Fairmont State University after 43 years of service, where he was awarded the Doctor of Humane Letters. He is also the recipient of the 2011 Excellence in Health Care Award presented by the WV Primary Care Association.

State Health Officer Honored with Distinguished Service Award

Dr. Letitia Tierney was honored by the West Virginia Poison Center for being an active partner, consultant, and advocate for the WV Poison Center.

CHARLESTON, W.Va. – The West Virginia Department of Health and Human Resources is pleased to announce that Dr. Letitia Tierney, State Health Officer and Commissioner for the Bureau for Public Health was presented with the West Virginia Poison Center's (WVPC) Distinguished Service Award on April 8, 2014.

The Distinguished Service Award is presented to individuals demonstrating exceptional and sustained service to the WVPC. Individuals receiving this award have distinguished themselves by their active advocacy for the WVPC, support of the WVPC during times of immediate need, and their demonstrated commitment to the viability of the WVPC.

"I admire her diligence and continued efforts to protect the health of the community in spite of the difficulties she has been faced with," said Dr. Elizabeth Scharman, director of the WVPC. "She is a true professional and is committed to doing what is best for those she serves."

Scharman said Tierney is an active partner, consultant and advocate for the West Virginia Poison Center, who diligently and consistently works with the WVPC to utilize and enhance joint collaborative efforts between the WVPC and public health agencies for the benefit of the community she serves.

West Virginia is fortunate to have Dr. Scharman and her team on call 24/7 to ensure the public has immediate access to potentially lifesaving health information."

Tierney is just the third recipient of the West Virginia Poison Center's Distinguished Service Award.

Legislative News

This year, two important bills, supported by Board of Medicine, were passed by the legislature and became law on June 6, 2014.

House Bill 4278 updated sections of the West Virginia Medical Practice Act, specifically §30-3-15, which governs medical corporations and delineates the Board's role in the issuance of certificates of authorizations to medical corporations. This bill clarified the mechanism by which a domestic medical corporation or podiatry corporation may obtain a certificate of authorization to practice medicine in West Virginia through licensed physicians and podiatrists. The bill also authorized the issuance of certificates of authorization under specific circumstances to physician-owned corporations formed in other states who wish to practice medicine in West Virginia through the corporation.

Specifically, this revised section of the Medical Practice Act:

- Sets forth clear eligibility guidelines and application processes and procedures for the issu ance of certificates of authorization to practice medicine and surgery to corporations formed in West Virginia by West Virginia licensed physicians or podiatrists.
- Permits the issuance certificates of authorization to practice in West Virginia to medical and podiatry corporations formed in other states when:
- The corporation is fully physician and/or podiatrist owned; The corporation is authorized to practice medicine, surgery or podiatry in its state of incorporation and such authorization is in good standing; The corporation ownership, at all times, includes at least one physician or podiatrist licensed in West Virginia; and The corporation designates a West Virginia li censed physician or podiatrist shareholder for all communications with the board regarding the designation and continuing authorization of the corporation as a foreign medical/podiatry corporation.
- Establishes circumstances under which medical and/or podiatry corporations must cease practicing pursuant to a certificate of authorization.
- Establishes that a certificate of authorization expires, if not biennially renewed.

The new language can be found in §30-3-15. Those who are seeking to establish or maintain Medical Corporations within our state may wish to make themselves familiar which this revised section of the Act, which may be accessed through our website at **www.wvbom.wv.gov**.

Legislative News

The second Bill of major importance to the Board to pass the legislature this year is SB 425, which is referred to as the Physician Assistants Practice Act.

This Bill was proposed in close collaboration with the Board of Osteopathic Medicine as both Boards license and regulate the practice of physician assistants (PAs) who work under the supervision of physicians. This Bill creates a separate article, 3E, which was developed under Chapter 30, Profession and Occupations, to allow both Boards a shared legal platform from which to license and regulate Physician Assistants in a uniform manner. In doing so, Sections §30-3-16 and §30-3-16a of the Medical Practice Act related to physician assistants have been repealed and replaced by the new law.

The Physician Assistants Practice Act modernizes the licensure and regulation of PAs by the West Virginia Board of Medicine and the Board of Osteopathic Medicine. It permits physician assistants to obtain licensure prior to finding employment, prohibits physician assistants from practicing without an approved practice agreement on file with the Boards and authorizes physician assistants to practice under volunteer licenses/endorsements. The bill does not modify in any way the established scope of practice for PAs.

Highlights of the Physician Assistants Practice Act include:

- Separation of PA licensure from employment. Under previous law, a physician assistant would only receive a license from the Boards if he or she had already secured employment and a supervising physician. PAs were the only category of licensed mid-level healthcare practitioners in this state who could not receive a license without an employer. The law now permits the licensure of PAs without consideration of the PA's employment status.
- Requirement that a Physician/PA team file a Practice Agreement with the Board and receive authorization before a PA engages in supervised practice. Because PAs practice as part of a physician-led team, a PA may not practice unless he or she has a supervising physician. The law prohibits a PA from practicing until he or she, along with the supervising physician, files a practice agreement with the appropriate Board and receives authorization to practice.
- Streamlining the Administrative Application Process. PAs were previously required to receive approval for their job description, requested advance duties, job location (s) and limited prescriptive writing authority at the Board of Medicine through different application processes. Moreover, prescriptive writing privileges were requested per supervisor and per physical location. The new law streamlines the administrative process and combines all of these processes and requests into the proposed Practice Agreement. In many circumstances, proposed practice agreements may be reviewed and approved by the Board without the need to await the next scheduled meeting of the full Board.
- Expansion of number of PAs a Physician May Supervise. The utilization of PAs has proliferated in the last twenty years across the entire health care landscape. Physician assistants now work as part of physician-led teams in virtually every specialty and practice setting. Previous law permitted a physician to supervise up to three PAs at a time. The new law has increased this limit to five which is consistent with the patient-centered medical home (PCMH) model of healthcare that has been embraced by this state. It also permits PAs to be utilized to the fullest extent of their experience, education and training. The new law also accounts for the unique concerns, including scheduling concerns, for hospital-based practice settings by permitting physicians in that practice setting to supervise up to five PAs per shift.

- Authorization for Emergency, Volunteer and Summer Camp PA Practice. The previous law did not provide a specific mechanism for the authorization of practice by PAs in emergency situations, at summer camps or for volunteer practice at public and/or community events. The new law establishes protocol and criteria which more easily permits PAs to practice in each of these circumstances.
- Clarification of due process rights and disciplinary sanctions. The new law clarifies in statute that PAs
 are afforded the same due process and procedural protections as physicians and podiatrists in the
 licensure disciplinary process, and may be subject to the same disciplinary penalties for the same
 professional conduct violations.

The new law also authorizes the Board to promulgate legislative rules. On April 30, 2014, the Board submitted an Emergency Rule to implement the Physician Assistant Practice Act. The Secretary of State's office has approved Emergency Rule 11-1B, *Licensure, Disciplinary, and Complaint Procedures, Continuing Education, Physician Assistants*. The Emergency Rule became effective on June 6, 2014, to coincide with the enactment of the Physician Assistant Act. The Board also published a Notice of Comment Period on a Proposed Rule and received several thoughtful comments about the rule. An amendment to the Emergency Rule has been filed with the Secretary of State's Office, and became effective June 17, 20104.

The Physician Assistants Practice Act can be located through a link on the Board's website. The current amended Emergency Rule can be located under the "Rules" section of the Board of Medicine website. A link is also available in the Physician Assistant section of "Applications" where you will also find the revised License Application for Physician Assistants and the newly devised Practice Agreement form.

OTHER LEGISLATION OF NOTE

Thirty-six health related bills were passed during the 2014 legislative session. Four of the bills, in additional to the Physician Assistants Practice Act and the new provisions regarding medical corporations, have now become law, and may be important to your practice:

HB 4208 – Reclassifying certain prescription medications. Effective June 6, 2014, this bill moved the drug Tramadol from a non-scheduled drug to a Schedule IV controlled substance. Tramadol has been known to be abused by drug seekers when opioids become hard to obtain. Also Hydrocodone in Schedule III is limited to a prescription for a one-month supply. It now cannot be refilled more than three months after the original prescription, and cannot be refilled more than twice. This bill also bans additional synthetic hallucinogens and synthetic marijuana.

HB 4560 – Health Care Records. Also effective June 6, 2014, this bill amends W. Va. Code §16-29-1 and W. Va. Code §16-29-2 to mirror federal guidelines on the production of medical records to patients, and the charges that may be assessed for such copies. The new law permits charges to be assessed for labor, materials and delivery. Charges cannot exceed \$25 per hour for labor, subject to an annual CPI charge adjustment. The Board receives many inquiries from licensees and members of the public regarding the issue of medical record production and assessment of fees. The Board strongly encourages all licensees to become familiar with this new law.

SB602 – Health Care Transparency Act. With an effective date of July 1, 2014, this bill requires health care providers to wear ID badges and applies to health care providers who employ at least three licensed practitioners.

HB 4151 – Professional Board Licenses for those in the military and their spouses. Effective June 4, 2014, this bill serves to expedite the licensure process for members of the military by taking into consideration education, training and experience achieved while in the military. It also allows for the waiver of timelines, fees and continuing education requirements, under certain circumstances, for those in active duty and their spouses who accompany them during deployment outside of this state.

Also of legislative note, the DHHR Office of Health Facility Licensure and Certification (OHFLAC) has submitted the Emergency Rule for the Licensing and Regulation of Pain Management Clinics to the Secretary of State's office. This Rule, may be found on the Secretary of State's website at http://apps.sos.wv.gov/adlaw/csr/readfile.aspx?DocId=25801&Format=PDF. This Emergency Rule has been accepted by the Secretary of State's Office and goes into effect July 1, 2014. Further information can now also be found at OHFLAC at http://ohflac.wv.gov/.

FDA Approves first hydrocodone-only opioid narcotic, Zohydro Extended Release (ER)

Despite an 11-2 vote against the approval of this drug by the FDA's own Anesthetic and Analgesic Drug Advisory Committee, the FDA approved the use of Zohydro ER. This drug was released on the market in March of this year. Zohydro ER, which lacks abusive deterrent properties, may contain up to 10 times the hydrocodone found in the heavily abused combination products such as Vicodin and Lortab. Given that our state continues to have one of the highest drug overdose mortality rates in the country, there is great concern over such a potent and potentially lethal drug being made so readily available. In response to this serious concern, the Board, with the assistance of the West Virginia Medical Professionals Health Program and at the suggestion of West Virginia Attorney General Patrick Morrisey, has compiled several links, (these may be accessed on our website, www.wvbom.wv.gov), which will aid physicians in understanding the risks this drug presents, as well as further information regarding drug itself. It is recommended that great care be taken in the controlled prescribing and use of this drug.

The Board of Medicine strongly urges all physicians to become familiar with the Board's policy on the Use of Opioid Analgesics in the Treatment of Chronic Pain in addition to taking the required course on **Best Practice Prescribing of Controlled Substances and Drug Diversion Training** which can be linked to from our Home Page.

Middle East Respiratory Syndrome Coronavirus (MERS-CoV) cases identified in United States

RENEWAL RESULTS-2014

As of June 30th, the West Virginia Board of Medicine completed its annual licensure renewal period for all medical doctors whose last name began with the letters A through L. A total of 3,942 medical doctors were eligible to renew their licenses this year. From this total 2,947 medical doctors renewed their licenses in ACTIVE status. An additional 209 doctors renewed in INACTIVE status. Further, 786 medical doctors elected not to renew their West Virginia licenses. Of these physicians, 523 were medical doctors practicing outside of the state. Also, 231 of those that did not renew were age 60 and above. Of those medical doctors who were eligible to renew online only 3.3% chose a paper application. The Board of Medicine will continue to increase its efforts to provide a full online renewal system as the primary vehicle for the renewal process.

Ms. Grebb and Ms. Walker, together with PA Coordinator, Amy Callihan staff the Licensing Unit. Ms. Frame is our new Receptionist and Office Assistant, working under the supervision of Ms. Jett.
