With a quorum of members present, Dr. Sheth called the meeting to order, and attendance was documented by Ms. Frame.

**CALL TO
ORDER**

Dr. Rahim requested that the Board hold a moment of silence in remembrance of the victims of the September 11, 2001 terrorist attacks. A moment of silence has held.

In order to minimize interruptions, Dr. Sheth asked all members to silence his/her cell phones.

Dr. Sheth announced that the board membership term for Dr. Lilly and Ms. Mayfield are scheduled to expire on September 30, 2023. Dr. Lilly and Ms. Mayfield have each served one term on the board, and therefore they are each eligible to be reappointed to serve a second term. Dr. Sheth thanked all members for their dedication and commitment to the Board.

Prior to today's meeting, the draft July 10, 2023 meeting minutes were made available for members to review. Dr. Rahim moved that the July 10, 2023 meeting minutes be approved as presented. Ms. Takubo seconded the motion, and the motion carried without opposition.

Mr. Spangler thanked board and staff members for their commitment and engagement during the weekend committee meetings.

Mr. Spangler announced that Jamie S. Alley, Deputy Director/General Counsel, is unable to attend today's meeting due to illness. The Board sends well wishes to Ms. Alley.

Mr. Spangler reported that he will be attending the Administrators in Medicine conference, which will be held in Gulf Shores, Alabama in October. Additionally, he will be attending the annual Interstate Medical Licensing Compact Commission meeting, which will be held in Denver, Colorado in November.

Dr. Sheth reported that the Executive/Management Committee met yesterday, September 10, 2023, at which time the Committee reviewed the fiscal reports and

purchasing card transactions for the months of April, May, June and July 2023. The Board continues to remain in a good financial position.

The Committee recommended that the Board establish the following 2024 Board meeting dates:

The motion of the Committee was given by Dr. Sheth, and the motion carried without opposition.

Dr. Sheth reported that the *West Virginia Medical Practice Act* requires that the Board President and Secretary sign licenses that are issued by the Board. The Committee elected to authorize and implement the use of digitally affixed signatures on initial licensure certificates. Board staff will be exploring ways to implement this with a quality product.

Prior to today's meeting, a proposed policy entitled *West Virginia Board of Medicine Investigator Firearm Policy* was made available for members to review. Dr. Sheth reported that Senate Bill 427 was enacted during the 2022 regular session of the West Virginia Legislature. This legislation authorizes West Virginia Board of Medicine Investigators to carry a concealed firearm while performing his/her official duties. The Committee recommended that the Board adopt the policy as written. The motion of the Committee was given by Dr. Sheth, and the motion carried without opposition.

Dr. Sheth reported that intravenous (IV) hydration businesses seem to be growing across the country, and often there are no industry specific guidelines or laws regarding the

operation of such businesses. Some state regulatory boards are starting to issue position statements regarding the intersection of these entities. The Committee directed Board staff to research IV hydration therapy business license and regulation requirements, as well as board policies, position statements and/or opinions in other states.

Dr. Sheth reported that the Committee received the following updates:

- Board staff submitted comments regarding the proposed amendments to three Interstate Medical Licensure Compact Commission (IMLCC) Rules. The IMLCC will consider all proposed comments that are received at its November 2023 meeting.
- In response to the Board of Medicine audit that was conducted by the West Virginia Purchasing Division, Board staff have modified internal processes, and have submitted a Corrective Action Plan to the Purchasing Division.
- Practitioners will receive an eblast later this week advising them that due to legislation enacted during the 2023 regular session of the West Virginia Legislature, a roster containing required information, including the practitioner's mailing address of record with the Board, will be published on the Board's website in December 2023. Practitioners will be given the opportunity to review and update his/her current mailing address prior to the roster being published.
- Board staff have begun reviewing all Board of Medicine application questions for potential updating and modernization. Proposed modifications will be presented to the Committee at a future meeting.
- It is anticipated that the database and website will be placed out for bid in the near future.
- Board staff who are eligible to participate in the telework pilot project will begin working from home one day a week beginning next week.

Dr. Sheth reported that the matter of *JH, Petitioner, v. West Virginia Board of Medicine, Respondent*, remains pending before the United State Supreme Court. The West Virginia Attorney General's Office is representing the Board in this matter.

Dr. Sheth reported that the Board currently has two staff vacancies. Board staff recently conducted interviews for the Receptionist/Administrative Office Assistant position, and it is anticipated that a candidate will be hired for this position soon. A Licensure Analyst/Special Projects Coordinator position was posted internally last week, and the deadline to apply for this position is September 14, 2023. The Board wishes Leisa Reed, former Receptionist/Administrative Office Assistant, and Melissa Cross, former Technical Writer/Administrative Assistant, the best in their future endeavors.

The Committee recommended that the Board accept and ratify the Executive/Management Committee Report. The motion of the Committee was given by Dr. Sheth, and the motion carried without opposition.

Mr. Foster reported that a hearing convened in May 2023. The Board is awaiting the Hearing Examiner's recommended decision in this matter.

Mr. Foster reported that it is anticipated that a *Complaint and Notice of Hearing* will be issued in the near future, setting a hearing to convene later this year.

Mr. Foster reported that on March 14, 2022 the Board issued a *Final Decision and Order* in the matter of *West Virginia Board of Medicine, Petitioner, v. Mark Samaan, MD, Respondent*, Complaint No. 18-175-M. The Respondent filed an appeal in Kanawha County Circuit Court which was dismissed on procedural grounds. He later filed an appeal in Kanawha County Intermediate Court. The Kanawha County Intermediate Court has remanded the case back to Kanawha County Circuit Court for a decision on the merits of the appeal. The Board's *Final Decision and Order* in this matter remains in effect.

Ms. Takubo reported that the Physician Assistant Committee met on Saturday, September 9, 2023, at which time one applicant appeared before the Committee to discuss

Ms. Takubo reported that the Committee reviewed an inquiry regarding physician assistant scope of practice and vasectomy care and directed Board staff to respond to the requestor advising that while the legislative rule governing physician assistant practice authorize physician assistants to assist with surgical procedures, neither the *Physician Assistant Practice Act* nor the legislative rule authorizes physician assistants to perform surgery independently. Physician assistants may participate in surgical procedures in collaboration with physicians who are performing surgical procedures, and as credentialed by a hospital.
