With a quorum of members present, Dr. Sheth called the meeting to order, and attendance was documented by Ms. Frame.

In order to minimize interruptions, Dr. Sheth asked all members to silence his/her cell phones.

**ANNOUNCEMENTS**

Dr. Sheth welcomed and introduced Amal Khan. Ms. Khan joined the Board in September; she serves as the licensure analyst for providers whose last names begin with the letters H through O.

Dr. Sheth congratulated Mr. Spangler, who recently became a Certified Medical Board Executive via the Administrators in Medicine certification process.

Dr. Sheth announced that Ms. Thornton and Patrick A. Muncie will recertify as Medical Board Investigators in February 2024.

Prior to today's meeting, the draft September 11, 2023 meeting minutes were made available for members to review. Dr. Dockery moved that the September 11, 2023 meeting minutes be approved as presented. Mr. Tipton seconded the motion, and the motion carried without opposition.

Mr. Spangler announced that the next Licensing Board Seminar will be held on November 7, 2024. Additionally, he reminded members that each member is required to attend the seminar once during each term of appointment.

Dr. Kukkillaya joined the meeting at this time.

Mr. Spangler reported that he will be attending the Interstate Medical Licensure Compact Commission meeting next week in Denver, Colorado. Additionally, Mr. Spangler reported that he and Dr. Lilly will attend the 2024 Federation of State Medical Boards Symposium on Artificial Intelligence in Health Care and Medical Regulation on January 17, 2024 in Washington, DC.

Dr. Sheth reported that the Executive/Management Committee met yesterday, November 5, 2023, at which time the Committee reviewed the fiscal reports and purchasing card transactions for the months of August and September 2023. The Board continues to remain in a good financial position.

Dr. Sheth reported that the Agreement between the Board of Medicine and the West Virginia Medical Professionals Health Program (WVMPHP) is scheduled to terminate on January 1, 2024. Prior to today's meeting, a copy of a proposed Agreement, which mirrors the current Agreement, was made available for members to review. The Committee recommended that the Board enter into the proposed Agreement with the WVMPHP for the period beginning January 1, 2024. The motion of the Committee was given by Dr. Sheth, and the motion carried without opposition.

Dr. Sheth reported that in September 2023, the Interstate Medical Licensure Compact Commission published the *New License Volume Data Report*, which contains statistical information related to Interstate Medical Licensure Compact (IMLC) licensure for 2019 through 2022. Prior to today's meeting, a copy of the Report was available for members to review. Licensure via the IMLC pathway continues to increase in West

Virginia and across member states. In 2022, the Board of Medicine issued 1,084 licenses, of which 453 licenses were issued via the IMLC pathway. Nationally, in 2022, 31% of initial licenses were issued via the IMLC pathway.

Dr. Sheth reported that the Committee received information concerning efforts to create interstate licensure compacts for podiatric physicians and physician assistants. The Interstate Podiatric Medical Licensure Compact is in the planning stages. The Physician Assistant Compact is available for legislative action. To date, two states have passed legislation enacting the Physician Assistant Compact.

Dr. Sheth reported that Board staff continue to work with credential holders to ensure that all providers have an opportunity to provide updated contact information in advance of the Board's implementation of the new roster requirement that was discussed at the September 2023 meeting.

Dr. Sheth reported that Board staff continue to work with the Director of Information Services for the West Virginia Office of Technology regarding technology updates to the board room and the conference room. The Board must obtain three verbal quotes prior to moving forward with the updates.

Dr. Sheth reported that it is anticipated that the database and website will be placed out to bid in the near future.

Dr. Sheth reported that in September 2023, Board staff who are eligible, and who elected to participate in the Board's telework pilot project, began working from home one day per week. Thus far, the project is going well.

Dr. Sheth reported that the matter of *JH, Petitioner, v. West Virginia Board of Medicine, Respondent*, remains pending before the United State Supreme Court. The West Virginia Attorney General's Office is representing the Board in this matter.

Dr. Sheth reported that in addition to hiring Ms. Khan, the Board has had one additional staffing change since the September meeting. In September, Samantha N. Gutierrez, who previously served as the Board's licensure analyst for providers whose last name begins with the letters H through O, applied for and accepted the position of Interstate Medical Licensure Compact Licensure Analyst and Special Projects Coordinator. Ms. Gutierrez is excelling in her new position.

The Committee recommended that the Board accept and ratify the Executive/Management Committee Report. The motion of the Committee was given by Dr. Sheth, and the motion carried without opposition.

Mr. Foster reported that a hearing convened in May 2023. The Board is awaiting the Hearing Examiner's recommended decision in this matter.

Mr. Foster reported that there is a hearing scheduled to convene on December 13, 2023.

Mr. Foster reported that on March 14, 2022 the Board issued a Final Decision and Order in the matter of *West Virginia Board of Medicine, Petitioner, v. Mark Samaan, MD, Respondent*, Complaint No. 18-175-M. The Respondent filed an appeal in Kanawha County Circuit Court which was dismissed on procedural grounds. He later filed an appeal in Kanawha County Intermediate Court. The Kanawha County Intermediate Court has remanded the case back to Kanawha County Circuit Court for a decision on the merits of the appeal. The Board's brief in this matter is due later this month. The Board's Final Decision and Order in this matter remains in effect.

Ms. Takubo reported that the Physician Assistant Committee met on Saturday, November 4, 2023, at which time one applicant appeared before the Committee to discuss his application. The Committee recommended that the following applicant be approved for physician assistant licensure:
