With a quorum of members present, Dr. Sheth called the meeting to order, and attendance was documented by Ms. Frame.

**CALL TO
ORDER**

In order to minimize interruptions, Dr. Sheth asked all members to silence their cell phones.

Dr. Sheth welcomed and introduced Emilie Lloyd. Ms. Lloyd joined the Board in December; she serves as the receptionist/administrative office assistant. The Board looks forward to working with Ms. Lloyd.

Dr. Dockery joined the meeting at this time.

Dr. Sheth reported that the deadline to file financial disclosures with the West Virginia Ethics Commission is February 1, 2024. Members should receive information directly from the Ethics Commission regarding this requirement.

Dr. Sheth announced that the 2024 Federation of State Medical Boards Annual Meeting will be held on April 18 – 20, 2024 in Nashville, Tennessee. Any member who is interested in attending should notify Mr. Spangler or Ms. Frame.

Prior to today’s meeting, the draft November 6, 2023 and December 11, 2023 meeting minutes were made available for members to review. Dr. Rahim moved that the meeting minutes be approved as presented. Dr. Kukkillaya seconded the motion, and the motion carried without opposition.

Mr. Spangler thanked board and staff members for their commitment and engagement during the weekend committee meetings.

**EXECUTIVE
DIRECTOR
REPORT**

Mr. Spangler reported that he and Dr. Lilly will attend the 2024 Federation of State Medical Boards Symposium on Artificial Intelligence in Health Care and Medical Regulation on January 17, 2024 in Washington, DC.

Mr. Spangler reported that Patrick Muncie, Ms. Thornton and himself will attend the Administrators in Medicine 2024 Certified Medical Board Investigator Training in Scottsdale Arizona on February 22 – 23, 2024.

Mr. Spangler reported that the 2024 regular session of the West Virginia Legislature will convene on January 10, 2024 and will conclude on March 9, 2024.

Dr. Sheth reported that the Executive/Management Committee and the Legislative Committee met jointly on December 14, 2023. At the December 14, 2023 meeting, and again yesterday, January 7, 2024, the Committees reviewed and considered a potential bill which would consolidate the West Virginia Board of Osteopathic Medicine with the West Virginia Board of Medicine, effective January 1, 2025. Prior to today's meeting, a copy of the potential bill was made available for members to review. Both of the Committees are generally supportive of the bill. The Board of Medicine's Joint Regulatory Concerns/Opportunities Committee will meet with members of the Board of Osteopathic Medicine later today to discuss the bill and board consolidation. The Committee recommended that the Board support the potential bill which would consolidate the Board of Osteopathic Medicine with the Board of Medicine. The motion of the Committee was given by Dr. Sheth, and the motion carried without opposition.

**EXECUTIVE /

COMMITTEE
REPORT**

Dr. Sheth reported that at the invitation of the Committee, Dr. Dockery attended yesterday's meeting and provided helpful information concerning the discussion surrounding the board certification criteria under consideration for the Interstate Podiatric Medical Licensure Compact (IPMLC), which is currently under development. The Committee appreciates the information provided by Dr. Dockery. As Mr. Spangler and Dr. Dockery are members of the IPMLC Task Force, the Committee requested that Dr. Dockery provide similar educational information to the IPMLC Task Force.

Dr. Sheth reported that the Committee reviewed the fiscal reports and purchasing card transactions for the months of October and November 2023. The Board continues to remain in a good financial position.

Dr. Sheth reported that Board staff have identified a need for the Board's Data-Sharing Agreement with the Federation of State Medical Boards to be reviewed and updated. The Committee recommended that the Board authorize Mr. Spangler to review, revise and enter into a new Data-Sharing Agreement with the FSMB to permit the Board to share information on all credential types and, if appropriate terms can be met to safeguard confidential personally identifiable information, date of birth for credential holders. The motion of the Committee was given by Dr. Sheth, and the motion carried without opposition.

Dr. Sheth reported that Constatino Ycong Amores, MD was granted a West Virginia medical license by the Board in 1974. He maintained an active status license until June 30, 2022, when he allowed his license to expire as he had retired from practice. Pursuant to a request, the Committee approved the issuance of a Certificate of Recognition to Dr. Amores for his years of medical licensure in the State of West Virginia.

Dr. Sheth reported that in light of the proliferation of intravenous (IV) hydration therapy clinics and questions received by the Board relating to such, the Committee directed Board staff to communicate with the West Virginia Board of Osteopathic Medicine, the West Virginia Board of Nursing and the West Virginia Board of Pharmacy to determine whether there is interest in developing a joint policy statement to provide guidelines and guardrails regarding IV hydration therapy clinics.

Dr. Sheth reported that the Committee reviewed an inquiry that was received from a non-medical provider regarding the possibility of opening an IV hydration therapy clinic. The Committee directed Board staff to respond to the requestor indicating that the Board is in the process of developing guidance related to IV hydration therapy, and at this time, the Board is not able to approve their business model as a medical practice.

Dr. Sheth reported that the Committee received a report from Mr. Spangler regarding the telework pilot program, which is going well. In advance of today's meeting, documentation regarding the telework pilot project program was made available for members to review. The Committee recommended that the Board eliminate the accrued leave eligibility requirement from the telework pilot program eligibility criteria. The motion was given by Dr. Sheth, and the motion carried without opposition.

Dr. Sheth reported that the matter of *JH, Petitioner, v. West Virginia Board of Medicine, Respondent*, remains pending before the United State Supreme Court. The West Virginia Attorney General's Office is representing the Board in this matter.

The Committee recommended that the Board accept and ratify the Executive/Management Committee Report. The motion of the Committee was given by Dr. Sheth, and the motion carried without opposition.

Dr. Rahim reported that the Legislative Committee met yesterday, January 7, 2024, at which time Mr. Spangler reported that the proposed amendments to W. Va. Code R. § 11-1B-1 *et seq.*, *Licensure, Practice Requirements, Disciplinary and Complaint Procedures, Continuing Education, Physician Assistants* and W. Va. Code R. § 11-6-1 *et seq.*, *Continuing Education for Physicians and Podiatric Physicians* were approved by the Legislative Rule Making Review Committee in 2023. Additionally, the Legislative Rule Making Review Committee approved extending the sunset provision date of W. Va. Code R. § 11-12-1 *et seq.*, *Permitting and Disciplinary Procedures: Educational Permits for Graduate Medical Interns, Residents and Fellows*. The three rules will be considered by the West Virginia Legislature during the 2024 legislative session.

LEGISLATIVE
COMMITTEE
REPORT

Dr. Rahim reported that the potential bill which would consolidate the West Virginia Board of Osteopathic Medicine with the West Virginia Board of Medicine would authorize the Board to license and regulate genetic counselors. Board staff are researching statutes in other states as they relate to the licensure and regulation of genetic counselors

and will bring proposed modifications/recommendations before the Committee at a future meeting.

Dr. Rahim reported that beginning on January 24, 2024 the Legislative Committee will meet at 5 pm every other Wednesday while the Legislature is in session. The Committee recommended that the Board delegate authority to the Committee to act on behalf of the Board as necessary to respond to legislative matters during the 2024 legislative session. The motion of the Committee was given by Dr. Rahim, and the motion carried without opposition.

The Committee recommended that the Board accept and ratify the Legislative Committee Report. The motion of the Committee was given by Dr. Rahim, and the motion carried without opposition.

Dr. Christiansen joined the meeting at this time.

Mr. Foster reported that on March 14, 2022 the Board issued a *Final Decision and Order* in the matter of *West Virginia Board of Medicine, Petitioner, v. Mark Samaan, MD, Respondent*, Complaint No. 18-175-M. Thereafter, the Respondent filed an appeal in Kanawha County Circuit Court which was dismissed on procedural grounds. He later filed an appeal in Kanawha County Intermediate Court. The Kanawha County Intermediate Court remanded the case back to Kanawha County Circuit Court for a decision on the merits of the appeal. The Kanawha County Circuit Court has entered an Order affirming the Board's Final Order.

Mr. Foster reported that a hearing convened in December 2023. This matter is currently going through the post hearing process and will be ripe for the Board's consideration at a future meeting.

Ms. Takubo reported that the Physician Assistant Committee met on Saturday, January 6, 2024. Ms. Takubo asked members to review the list of physician assistants up for action, and to advise of any conflicts. No conflicts were declared. Ms. Takubo reported that the Committee considered an inquiry from a physician assistant concerning expert witness work. The Committee authorized staff to advise the requestor that the specific expert work he identified was permissible, and that expert opinion and expert testimony by physician assistants which do not involve clinical practice do not require an active practice notification.

Ms. Takubo reported that the Committee reviewed the June 26, 2015 licensure Consent Order of Tyson E. Bubnar, PA and authorized correspondence to the licensee notifying him that his period of probation has concluded.


