With a quorum of members present, Dr. Sheth called the meeting to order, and attendance was documented by Ms. Frame.

**CALL TO  
ORDER**

In order to minimize interruptions, Dr. Sheth asked all members to silence their cell phones.

Dr. Sheth welcomed and introduced his wife, Jhanvi Sheth, his daughter, Falguni Sheth, and Dr. Challa's wife, Jaldasree Challa, who attended the meeting as guests.

Dr. Sheth announced that Dr. Challa would like to address the Board. Dr. Challa reported that after serving nearly twelve years on the Board, he is resigning from the Board, effective today, May 20, 2024. Dr. Challa thanked his fellow Board members for their service and for protecting the public. Dr. Sheth thanked Dr. Challa for his many years of service.

Dr. Sheth congratulated Dr. Patel, who was recently appointed to serve on the Federation of State Medical Boards Work Group on Oversight of Clinical Decision Making.

Dr. Sheth congratulated Mr. Spangler, who was recently elected to serve as President of Administrators in Medicine. Additionally, earlier this year, Mr. Spangler completed the Administrators in Medicine Certified Medical Board Executive Training and became a Certified Medical Board Executive. Mr. Spangler has also been appointed to serve on the Federation of State Medical Boards Finance Committee.

Dr. Sheth announced that in preparation for the election of officers at the July 2024 meeting, he has established a Nominating Committee which will consist of the following members:

The 2025 Federation of State Medical Boards Annual Meeting will be held on April 24-26, 2025 in Seattle, Washington. Additionally, Mr. Spangler reported that the Federation of State Medical Boards will hold a Board Attorneys Workshop in the fall. Mr. Spangler encouraged members who are available to plan to attend the Annual Meeting and/or the Board Attorneys Workshop

Mr. Spangler reported that the Board is in the midst of the 2024 renewal cycle, and he expressed his appreciation to the staff who are currently processing a tremendous number of applications.

Mr. Spangler reported that Dr. Kukkillaya was recently appointed to serve on the Board's Complaint Committee.

Mr. Spangler reported that Ms. Alley is not in attendance today as her mother is currently hospitalized. He asked members to keep Ms. Alley and her mother in their thoughts and prayers.

Mr. Spangler reported that unfortunately Dr. Lilly and Mr. Tipton had a negative encounter yesterday, May 19, 2024, with one or more police officers who were directing traffic at the intersection of Greenbrier Street and Hillcrest Drive in association with the USA Cycling Professional Road National Championships which were held this past weekend. Mr. Spangler reported that he intends to contact Mayor Amy Goodwin's Office to report the Board's concern over these matters.

Dr. Sheth reported that the Executive/Management Committee met yesterday, May 19, 2024, at which time the Committee received a report from P. Bradley Hall, MD, Executive Director of the West Virginia Medical Professionals Health Program, regarding the program's budget and funding. The Board appreciates the important contribution that the program makes to physician wellness and public safety.

**EXECUTIVE /

Dr. Sheth reported that the Committee reviewed and accepted the fiscal reports and purchasing card transactions for February and March 2024. The Board continues to maintain a good financial position.

Dr. Sheth reported that the Committee reviewed correspondence inquiring whether laser tattoo removal is considered the practice of medicine. The Committee directed Board

staff to gather additional information regarding the inquiry and research laser tattoo removal statutes, rules and guidelines in other states, and to report back to the Committee at a future meeting.

Dr. Sheth reported that the West Virginia Performance Evaluation and Research Division (PERD) recently conducted a performance review of the West Virginia Medical Imaging & Radiation Therapy Technology Board of Examiners. PERD staff are considering recommending to the Legislature the possibility of integrating the oversight of the medical imaging profession within the Board of Medicine. Three other states regulate these professions under the Board of Medicine. PERD staff contacted the Board seeking its opinion of their possible recommendation. The Committee directed Board staff to respond to PERD and advise that while the medical imaging professions interrelate with the professions regulated by the Board, the Board would need additional information in order to fully evaluate the possible integration. The Board appreciates PERD reaching out in advance of making a recommendation and is happy to engage in future conversations regarding this topic.

Dr. Sheth reported that the Committee received a report from Mr. Spangler regarding Provider Bridge, which is a national registry for health care professionals who are willing to assist during an emergency or a natural disaster. The Committee directed Board staff to place a link to the Provider Bridge website on the Board's website.

Dr. Sheth reported that the Committee received an update from staff regarding renewals. Renewal information will be provided later this morning as part of the Licensure Committee Report.

Dr. Sheth reported that in March, the Board approved the issuance of an invoice in the matter of *West Virginia Board of Medicine, Petitioner, v. David Nathaniel Smith, MD, Respondent*, Complaint No. 21-96-W, which assessed Dr. Smith the costs and expenses of the proceeding. Dr. Smith has not paid the costs and expenses of the hearing as required by

the Board's Final Order. The Committee directed Board staff to consult with the West Virginia Attorney General's Office regarding how to best proceed with this matter.

Dr. Sheth reported that in April 2024, senior leadership staff members met with members of the West Virginia Board of Pharmacy, the West Virginia Board of Osteopathic Medicine and the West Virginia Board of Registered Nurses to collaborate regarding developing a joint policy statement related to IV hydration therapy. The joint statement is currently being drafted and will be presented for consideration at a future meeting. Additionally, while attending the meeting, which was hosted by the Board of Pharmacy at their office, board staff were made aware of potential office space within the building, which may be available for lease. The Committee directed the executive director to contact the West Virginia Real Estate Division to explore alternative office spaces.

The Committee recommended that the Board accept and ratify the Executive/Management Committee Report. The motion of the Committee was given by Dr. Sheth, and the motion carried without opposition.

Dr. Sheth reported that the Personnel Committee met yesterday, May 19, 2024, at which time the Committee discussed salary increases for the coming year. The Committee recommended that the Board adopt the Executive Director's recommendation to participate in the Governor's across-the-table 5% increase to take effect on July 1, 2024, and at the Executive Director's discretion other merit-based salary adjustments for all staff and with the addition of the Committee's modification to increase the salary of the Executive Director, the Deputy Director and the Chief Disciplinary Counsel. The motion of the Committee was given by Dr. Sheth, and the motion carried without opposition.

**PERSONNEL

The Committee recommended that the Board accept and ratify the Personnel Committee Report. The motion of the Committee was given by Dr. Sheth, and the motion carried without opposition.

Mr. Foster reported that a hearing convened in December 2023 in the matter of *West Virginia Board of Medicine, Petitioner, v. Phillip Allen Peterson, MD*, Respondent, Complaint No. 22-86-W. On April 12, 2024, the Board entered a Final Decision and Order with regard to this matter. Counsel for Dr. Peterson has filed an appeal to the Intermediate Court of Appeals. The Court has not yet entered a Scheduling Order.

Ms. Takubo reported that the Physician Assistant Committee met on Saturday, May 18, 2024. The Committee had requested that interstate telehealth registration applicant Lemuel Pierre meet with the Committee concerning his application. The applicant has requested an accommodation to appear on any day other than Saturday. The Executive/Management Committee has agreed to conduct the interview at its July 14, 2024 meeting.

Ms. Takubo asked members to review the list of physician assistants up for action, and to advise of any conflicts. No conflicts were declared. The Committee recommended that each of the following ten applicants be approved for initial physician assistant licensure:

The motion of the Committee was given by Ms. Takubo, and the motion carried without opposition.

Ms. Takubo reported that the Committee received an inquiry from a physician assistant concerning central venous catheter placement. The Committee directed staff to thank the physician assistant for the submission of supervised logs and notify the physician assistant that under the current regulatory process established in the amended Physician Assistants Practice Act, decisions concerning most scope of practice issues, including central venous catheter placement, are determined at the practice level by the health care facility, physician assistant and collaborating physician based upon the education, training and experience of the physician assistant. No additional endorsement or authorization from the Board is required.

Ms. Takubo reported that there were twenty-six physician assistants eligible to renew their interstate telehealth registration during the 2024 renewal period; of which, twenty-two physician assistants successfully renewed their registration.

The motion of the Committee was given by Ms. Takubo, and the motion carried without opposition.

Ms. Takubo reported that there are some physicians who currently hold a West Virginia medical license issued through the Interstate Medical Licensure Compact Commission who are not eligible to renew through the compact process. The Committee authorized staff to communicate with these licensees and provide a pathway to convert their existing Interstate Medical Licensure Compact license to a traditional West Virginia medical license. Upon receipt of all traditional application components, staff may effectuate the conversion so that these physicians may renew via the traditional renewal process.

Ms. Takubo reported that Interstate Telehealth Registration Renewal concluded on March 29, 2024. One hundred and thirty-eight physicians successfully renewed their registration and twenty-six registrations expired due to non-renewal.
