**CALL TO** 

ORDER

Dr. Mullins called the meeting to order.

#### **APPROVAL**

MINUTES Ms. Mayfield made a motion to approve the minutes of the April 30, 2023 Complaint Committee meeting, the May 18, 2023 Special Complaint Committee meeting, and the May 22, 2023 Emergency Complaint Committee meeting. Dr. Lilly seconded the motion, and the motion carried.

**COUNSEL REPORT** Mr. Foster provided an update with respect to the Consent Orders offered by the Committee. Since the April meeting, a fully executed Consent Order has been entered with respect to each of the following licensees:

#### **EXECUTIVE**

SESSION Ms. Mayfield made a motion that the Public Session be recessed in order to enter into Executive Session pursuant to W. Va. Dr. Mullins designated Dr. Lilly to chair the meeting in his absence and left the meeting room.

Ms. Mayfield moved that the Committee offer the licensee a Consent Order with regard to Complaint No. 23-36-W. Dr. Lilly seconded the motion, and the motion carried.

Having completed discussion and action upon the matter in which Dr. Mullins declared a conflict, Dr. Mullins returned to the meeting room and was present for remainder of the meeting.

Ms. Mayfield declared a conflict in a Complaint Committee matter. The matter was identified as Complaint No. 23-15-W. Ms. Mayfield disclosed that her conflict relates to the fact that the licensee is a recent real estate client. Ms. Mayfield then exited the meeting room.

During her absence, Dr. Lilly moved that the Committee close Complaint No. 23-15-W. Mr. Tipton seconded the motion, and the motion carried. Having completed discussion and action upon the matter in which a conflict was declared, Ms. Mayfield returned to the meeting room and was present for remainder of the meeting.

Mr. Tipton declared a conflict with regard to Complaint No. 23-57-W. Mr. Tipton disclosed that his conflict relates to the fact that his wife is a member of the Board of Directors at a facility where the licensee recently practiced. Mr. Tipton then left the meeting room.

During his absence, Ms. Mayfield moved that a Consent Order be offered to the licensee with respect to Complaint No. 23-57-W. Dr. Lilly seconded the motion, and the motion carried. Having completed discussion and action upon the matter in which a conflict was declared, Mr. Tipton returned to the meeting room and was present for remainder of the meeting.
