With a quorum present, Dr. Patel called the meeting to order. The Committee reviewed the minutes for the April 29, 2023 meeting. Rev. Harman moved that the Committee approve the minutes. Mr. Wooton seconded the motion, and the motion carried.

CALL TO ORDER

APPROVAL OF MINUTES

**Helene Dabbous, MD** appeared before the Committee via Zoom in support of her application for medical school faculty licensure. After a thorough discussion with Dr. Dabbous, Rev. Harman moved that the Committee grant the applicant a medical school

faculty license to practice medicine and surgery at the medical center of West Virginia University School of Medicine in Morgantown, West Virginia. Dr. Dockery seconded the motion, and the motion carried.

Mitchell Anthony Kohl, MD appeared before the Committee via Zoom in support of his application for medical licensure. After a thorough discussion with Dr. Kohl, Dr. Kukkillaya moved that the Committee recommend that the Board grant the applicant a license to practice medicine and surgery in West Virginia. Mr. Wooton seconded the motion, and the motion carried.

**Jeniffer Ann Ronan, MD** appeared before the Committee in support of her application for medical licensure. After a thorough discussion with Dr. Ronan, Dr. Kukkillaya moved that the Committee place Dr. Ronan's application on hold pending additional information. Dr. Devaraj seconded the motion, and the motion carried.

No conflicts having been declared, Dr. Kukkillaya moved that the Committee approve the initial medical licensure applicants and recommend that the Board grant each applicant a license to practice medicine and surgery in West Virginia. Mr. Wooton seconded the motion, and the motion carried.

The Committee received and reviewed a list of three initial podiatric licensure applicants whose applications did not require appearances or individualized discussions. A

complete list of the initial podiatric applicants considered by the Committee is attached to these minutes and incorporated herein by reference as Attachment 2.

Members of the Committee reviewed the list for conflicts. No conflicts having been declared, Dr. Kukkillaya moved that the Committee approve the initial podiatric licensure applicants and recommend that the Board grant each applicant a license to practice podiatric medicine and surgery in West Virginia. Mr. Wooton seconded the motion, and the motion carried.

The Committee received a report on 2023 renewal. Renewal for M-Z physicians, all podiatric physicians, corresponding controlled substance registrations, educational permits and PLLCs began on May 3, 2023 and ended at 4:30pm EDT on June 30, 2023.

The Committee received a report on licensure activity for fiscal year 2023, which began on July 1, 2022 and ended on June 30, 2023. Over 2,000 initial credentials were issued during fiscal year 2023. Of note, IMLC pathway licensing continue to grow, and accounts

for over 40% of all new physician licensees.

There being no further business, Dr. Deveraj moved that the meeting be adjourned. ADJOURNMENT
