No conflicts having been declared; Dr. Patel moved that the Committee recommend each of the preceding forty-eight applicants for physician assistant licensure by the Board. Dr. Kukkillaya seconded the motion, and the motion carried.

The Committee reviewed the application for Reid Joseph Van Bussum, PA for initial physician assistant licensure. Rev. Harman moved that the Committee request Mr. Van Bussum's appearance at its November 2023 Committee meeting. Dr. Patel seconded the motion, and the motion carried.

The Committee reviewed an inquiry regarding physician assistant scope of practice **DISCUSSIONS** and vasectomy care. Dr. Kukkillaya moved that the Committee respond to the requestor by advising that: (1) While the legislative rules governing physician assistant practice authorize PAs to assist with surgical procedures, neither the Physician Assistant Practice Act nor the legislative rule authorize PAs to perform surgery independently; and (2) Physician assistants may participate in surgical procedures in collaboration with physicians who are performing surgical procedures, and as credentialed by a hospital. Rev. Harman seconded the motion, and the motion carried.
