With a quorum of members present, Dr. Sheth called the meeting to order, and attendance was documented by Ms. Frame.

**CALL TO
ORDER**

In order to minimize interruptions, Dr. Sheth asked all members to silence their cell phones.

Dr. Sheth congratulated Dr. Challa on his recent induction into the West Virginia Executive magazine's Health Care Hall of Fame, which recognizes individuals who go above and beyond in the health care industry.

Dr. Sheth congratulated Dr. Christiansen and his wife on the birth of Juniper Estele Shell, who was born on February 29, 2024.

Dr. Sheth reminded members that the 2024 Federation of State Medical Boards Annual Meeting will be held on April 18 – 20, 2024 in Nashville, Tennessee. Any member who is interested in attending should notify Mr. Spangler or Ms. Frame.

On behalf of the Board, Dr. Sheth expressed his condolences to Ms. Takubo and her family as her father passed away a few days ago.

Prior to today's meeting, the draft January 8, 2024 meeting minutes were made available for members to review. Dr. Rahim moved that the meeting minutes be approved as presented. Dr. Kukkillaya seconded the motion, and the motion carried without opposition.

Mr. Spangler thanked board and staff members for their commitment and engagement during the weekend committee meetings.

**EXECUTIVE
DIRECTOR
REPORT**

Mr. Spangler reported that Patrick Muncie, Ms. Thornton and himself attended the Administrators in Medicine 2024 Certified Medical Board Investigator Training in Scottsdale Arizona on February 22 – 23, 2024.

Mr. Spangler reported that he and Ms. Alley recently had a conversation with members of the West Virginia Performance, Evaluation and Research Division, who expressed that the Board of Medicine operates very efficiently and is the gold standard in regulatory boards.

Mr. Spangler reported that Senate Bill 714, transferring duties and licensing from the Board of Osteopathic Medicine to the Board of Medicine, was passed during the 2024 legislative session, which concluded on March 9, 2024; however, the Governor is being urged to veto the bill.

Dr. Sheth reported that the Executive/Management Committee met yesterday, March 10, 2024, at which time the Committee reviewed and accepted the fiscal reports and purchasing card transactions for December 2023 and January 2024. The Board continues to maintain a good financial position.

REPORT**

Prior to today’s meeting, Senate Bill 714, transferring duties and licensing from the Board of Osteopathic Medicine to the Board of Medicine, was made available for members to review. Dr. Sheth reported that Senate Bill 714 was passed during the 2024 legislative session and is awaiting the Governor’s signature. This bill consolidates the Board of Osteopathic Medicine with the Board of Medicine effective January 1, 2025. Pursuant to the bill, the Board of Medicine will consult with the Board of Osteopathic Medicine to develop and implement a transition plan, which is to be submitted to the Joint Committee on Government Finance, the Governor, the Secretary of State, the Department of Administration and the Division of Personnel no later than July 1, 2024. In advance of discussing and/or sharing confidential and nonpublic information, the Committee directed Board staff to develop and enter into a Confidentiality Agreement with the Board of Osteopathic Medicine. Additionally, the Committee approved the establishment of a Transition Committee. Dr. Sheth announced that he will soon be appointing members to serve on the Transition Committee.

Dr. Sheth announced that Senate Bill 714 also creates a new code section which establishes a Genetic Counselors Practice Act. Board staff will begin drafting a rule related to the licensure and regulation of genetic counselors, which will be presented for consideration at a future meeting.

Prior to today's meeting, a proposed invoice in the matter of *West Virginia Board of Medicine, Petitioner, v. David Nathaniel Smith, MD, Respondent*, Complaint No. 21-96-W was made available for members to review. Dr. Sheth reported that in December 2023, the Board issued a Final Decision and Order, which among other things, required Dr. Smith to pay the costs and expenses of the proceeding. The Committee recommended that the Board approve the invoice in this matter. The motion was given by Dr. Sheth, and the motion carried without opposition.

Dr. Sheth reported that the Committee reviewed correspondence that was received from a physician raising concerns related to companies who charge a fee to connect physician assistants and nurse practitioners with collaborating physicians who can provide regulatory required collaboration for controlled substance prescribing. The Committee directed Board staff to gather additional information and report back to the Committee at a future meeting.

Dr. Sheth reported that the Committee received an update regarding current and upcoming renewals. Renewal information will be provided later this morning as part of the Licensure Committee Report.

Dr. Sheth reported that during the 2023 legislative session, legislation was enacted which required licensing boards, including the Board of Medicine, to publish a roster which contains required information for practitioners, including the practitioners mailing address of record with the Board, on the Board's website. During the 2024 legislative session, Senate Bill 438, modifying roster requirements of authorizing entities, was passed. This bill removes the requirement that the mailing address for practitioners be included on the roster. The roster will be published on the Board's website and will be updated monthly.

Dr. Sheth reported that since September 2023, Board staff who are interested in and eligible to participate in the Board’s telework pilot program have been working remotely one day per week. The program continues to go well. The Committee recommended that the Board transition the telework pilot program to a standing program. The motion of the Committee was given by Dr. Sheth, and the motion carried without opposition.

Dr. Sheth reported that the Board of Medicine, in conjunction with the Board of Osteopathic Medicine, the Board of Pharmacy and the Board of Nursing, will begin developing a joint policy statement regarding IV hydration therapy.

The Committee recommended that the Board accept and ratify the Executive/Management Committee Report. The motion of the Committee was given by Dr. Sheth, and the motion carried without opposition.

Dr. Rahim reported that the Legislative Committee held four interim meetings since the regularly scheduled January meeting to review and consider bills that were introduced during the 2024 legislative session. Additionally, the Committee met yesterday, March 10, 2024.

LEGISLATIVE
COMMITTEE
REPORT

Dr. Rahim reported that the 2024 legislative session concluded on Saturday, March 9, 2024. The following bills which were closely monitored during the 2024 legislative session were passed:

- **House Bill 4110**, which was the rules bundle which included the following Board of Medicine Rules:
 - W. Va. Code R. § 11-1B-1 *et seq.*, *Licensing of Physicians and Podiatric Physicians and Disciplinary Procedures for Applicants, Licensees, Credential Holders*;
 - W. Va. Code R. § 11-6-1 *et seq.*, *Continuing Education for Physicians and Podiatric Physicians*; and
 - W. Va. Code R. § 11-12-1 *et seq.*, *Permitting and Disciplinary Procedures: Educational Permits for Graduate medical Interns, Residents and Fellows*.
- **Senate Bill 300** – relating to the organization of the Office of the Inspector General.

- **Senate Bill 438** – modifying roster requirements of authorizing entities.
- **Senate Bill 477** – prohibiting public disclosure of personal information on the internet.
- **Senate Bill 667** – creating a Physician Assistant Compact. In advance of the meeting, a copy of Senate Bill 667 was made available on the cloud for members to review.
- **Senate Bill 714** – combining the Board of Osteopathic Medicine with the Board of Medicine.
- **House Bill 5105** – eliminating the vaccine requirements for public virtual schools.

Dr. Rahim thanked Committee members and staff for all of their hard work during the legislative session.

Dr. Rahim reported that W. Va. Code R. § 11-13-1 *et seq.*, Waiver of Initial Licensing Fees for Certain Initial Licensure Applicants, is scheduled to sunset on August 2, 2025. The Committee does not feel that the rules needs to be modified at this time; therefore the Committee recommended that the Board authorize staff to file a Sunset Extension Request with the West Virginia Secretary of State’s Office, which would allow the Board to update the sunset expiration date to August 1, 2030 and maintain the remainder of the rule without modification. The motion of the Committee was given by Dr. Rahim, and the motion carried without opposition.

The Committee recommended that the Board accept and ratify the Legislative Committee Report. The motion of the Committee was given by Dr. Rahim, and the motion carried without opposition.

Mr. Foster reported that a hearing convened in December 2023. The parties in this matter have submitted post hearing documents, and the matter will be ripe for the Board’s consideration at a future meeting.

Dr. Patel reported that the Committee received an update on bills that have completed the 2024 legislative session and which relate to physician assistants, including Senate Bill 714, transferring duties and licensing from the Board of Osteopathic Medicine to the Board of Medicine, and Senate Bill 667, Creating a Physician Assistant Compact.

Dr. Patel reported that interstate telehealth registration renewal is currently underway, and will conclude on Friday, March 29, 2024. Nine of the twenty-six physician assistant interstate telehealth registrants have renewed their registration.

Dr. Patel reported that on August 17, 2022, Michael Antonio Reynolds, MD and the Board entered into a Consent Order which issued Dr. Reynolds a medical license and restricted his practice in West Virginia to the specialty of addiction medicine with additional terms and conditions, including participation in the West Virginia Medical Professionals Health Program and his maintenance and submission of controlled substance prescribing logs beginning on November 1, 2022. Dr. Reynold's appeared before the Committee pursuant to the terms of the Consent Order, which requires him to appear annually. No action is required at this time. The Committee will continue to monitor the Consent Order.

The motion of the Committee was given by Dr. Patel, and the motion carried without opposition.

A list of two applicants for initial podiatric licensure is attached to these minutes as Attachment 3 and is incorporated herein by reference. Dr. Dockery declared a conflict with regard to Ernest Paul Luczkowski, DPM, as Dr. Luczkowski plans to be employed by the same practice as Dr. Dockery if he is granted a license. Dr. Dockery left the meeting room at this time. The Committee recommended that the Board approve Dr. Luczkowski for podiatric licensure. The motion of the Committee was given by Dr. Patel, and the motion carried without opposition. Dr. Dockery returned to the meeting room at this time and was present for the remainder of the meeting.

The Committee recommended that the Board approve the remaining applicant identified on the list of applicants for initial podiatric licensure for podiatric licensure. The

motion of the Committee was given by Dr. Patel, and the motion carried without opposition.

Dr. Patel reported that the Licensure Committee received an update on bills that completed the 2024 legislative session, including Senate Bill 377, exempting certain physicians from specified traffic laws when responding to emergencies, Senate Bill 667, creating a Physician Assistant Compact, and Senate Bill 714, transferring duties and licensing from the Board of Osteopathic Medicine to the Board of Medicine, which were part of the Legislative Committee report earlier this morning.

Dr. Patel reported that interstate telehealth registration renewal is currently underway, and will conclude on Friday, March 29, 2024. Eighty-three of the one hundred sixty-four medical doctor interstate telehealth registrants have renewed. Renewal for physicians whose last name begins with the letters A through L, corresponding controlled substance dispensing registrations, educational permits and all professional limited liability

companies will begin on Wednesday, May 1, 2024 and will conclude at 4:30 pm on Friday, June 28, 2024.

The Committee recommended that the Board accept and ratify the Licensure Committee Report. The motion of the Committee was given by Dr. Patel, and the motion carried without opposition.

Dr. Mullins reported that the Complaint Committee met yesterday, March 10, 2024, at which time, having found no basis to proceed, the Committee elected to close the following eleven complaints without further action or disciplinary process:

All Consent Orders are available for review on the Board's website.

Dr. Mullins reported that on March 17, 2020, Parth Sarathi Bharill's West Virginia license was mandatorily revoked by the Board as required by section 30-3-14(d) of the Medical Practice Act. The Order of Revocation was based upon Dr. Bharill's conviction on February 4, 2020, of one felony count of conspiring to distribute suboxone outside the normal course of professional practice. Dr. Bharill was sentenced to 6 months of home detention and 5 years of probation. He was also ordered to pay a \$50,000.00 fine, an assessment of \$100.00, and \$23,076.95 in restitution. W. Va. Code § 30-3-14(d) provides that a physician whose license has been mandatorily revoked under this section may apply for re-licensure upon completion of their sentence and full satisfaction of any fines or other fees imposed by

the Court. The Board may grant the petition upon finding that the physician is, except for the underlying conviction, otherwise qualified to practice medicine. Provided, the Board may place whatever terms, conditions and limitations it deems appropriate upon the physician.

Dr. Bharill has submitted a petition to reactivate his revoked license and has provided evidence that he has satisfied all preconditions to be eligible to reactivate his revoked license. Dr. Bharill completed his sentence of home confinement and was granted early termination of his probation period by the Court on January 25, 2023. He also provided proof of his satisfaction of all fines and court fees. Dr. Bharill provided additional information, including that:

- His Iowa medical license was fully reinstated to unrestricted status on November 17, 2022
- His Pennsylvania medical license was fully reinstated to unrestricted status on February 24, 2023
- He is currently board certified in the medical specialties of internal medicine and gastroenterology and is participating in maintenance of certification.

On January 7, 2024 Dr. Bharill appeared before the Complaint Committee to discuss his petition for re-licensure.

Based upon its review of Dr. Bharill's application and his appearance, the Complaint Committee recommended that the Board find that except for the underlying conviction, Dr. Bharill is otherwise qualified to practice medicine and surgery in West Virginia, subject to the terms, conditions and limitations regarding his re-entry into clinical practice, as set forth in a proposed Consent Order which is available on the cloud for review and approval.

Dr. Kukkillaya moved that the Board enter into executive session to obtain legal advice. Dr. Patel seconded the motion, and the motion carried without opposition. The Board entered into executive session at this time.

The executive session concluded, and the Board reentered public session. The Committee renewed its above-stated recommendation. The motion of the Committee was given by Dr. Mullins, and the motion carried without opposition.

There being no further business to consider, Dr. Rahim moved that the meeting adjourn. Dr. Patel seconded the motion, and the motion carried without opposition.
