Licensure Committee Meeting Minutes

May 18, 2024

The Licensure Committee of the West Virginia Board of Medicine met at 101 Dee Drive, Charleston, West Virginia, on May 18, 2024, at 10:00 am.

With a quorum present, Dr. Patel called the meeting to order. The Committee	CALL TO
reviewed the minutes for the March 9, 2024, meeting. Ms. Takubo moved that the Committee	ORDER
approve the minutes. Dr. Devaraj seconded the motion, and the motion carried.	APPROVAL OF MINUTES

Stephen James Balise, MD, appeared before the Committee in support of hisAPPEARING
APPLICANTapplication for initial medical licensure. After a thorough discussion with Dr. Balise, Rev.Harman moved that the Committee recommend that Dr. Balise's application for West

Virginia medical licensure be granted. Mr. Wooton seconded the motion, and the motion carried.

At this time, Mr. Wooton left the meeting and was absent for the remainder of the Committee's meeting.

With a quorum still present, the Committee reviewed the request of **Sassan Naderi**, **MD** to withdraw his application for West Virginia medical licensure. Ms. Takubo moved that the Committee recommend that the Board grant Dr. Naderi's request to withdraw. Dr. Dockery seconded the motion, and the motion carried.

RETURNING DISCUSSIONS

The Committee reviewed the reactivation application of **Ugoala Chikezie Banks**, **MD**. Dr. Banks appeared before the Committee in March in support of his application for reactivation of expired medical licensure, at which time the Committee and Dr. Banks engaged in robust discussion. The Committee communicated with Dr. Banks after his appearance and offered him two pathways forward: (1) update his Uniform Application so that the Chronology of Activities accurately and completely reflects his work experience and re-take the SPEX; or (2) withdraw his application. Thereafter, Dr. Banks retained legal counsel and advised the Board that he declines to retake the SPEX. Additional information was submitted on behalf of Dr. Banks in support of his request to reactivate licensure, including affidavits from two physicians who have practiced with Dr. Banks, and newly disclosed information concerning Dr. Banks' practice of medicine and surgery for the Ohio Department of Corrections. Ms. Takubo moved that Dr. Banks' application be placed on hold and that he be given an opportunity to submit information from the ODC concerning his practice at their facilities. Dr. Dockery seconded the motion, and the motion carried.

The Committee reviewed the application of **Jonathan Thomas Cobb**, **MD**, for initial medical licensure. Dr. Cobb appeared before the Committee in March in support of his application. Thereafter, the Committee requested that Dr. Cobb submit evidence of satisfactory completion of his family medicine residency. Dr. Cobb has submitted evidence that he successfully completed training in April 2024. Rev. Harman moved that

the Committee recommend that the Board approve Dr. Cobb's application and grant him a West Virginia medical license. Dr. Dockery seconded the motion, and the motion carried.

The Committee reviewed and discussed the application of **Steven Anthony Kagan, MD**, to convert his expedited license, issued through the Interstate Medical Licensure Compact Commission to a traditional West Virginia medical license. Dr. Kagan submitted all component parts of a traditional license application. Ms. Takubo moved that the Committee recommend that the Board grant the applicant's request and convert his license to a traditional medical license. Dr. Dockery seconded the motion, and the motion carried.

The Committee reviewed and discussed the application of **Kousigan Chetipati Vadivelu, MD,** for an initial medical license. He was unable to obtain primary source verification of his first medical school, St. Luke's Medical School in Liberia, which has since closed. The applicant was able to obtain verification of his medical education from his school of graduation, Angeles School Foundation in the Philippines, which accepted credits from St. Luke's. Dr. Devaraj moved that the Committee accept the applicant's medical school education as satisfactorily verified and recommend that the Board grant the applicant a license to practice medicine and surgery in West Virginia. Dr. Dockery seconded the motion, and the motion carried.

The Committee reviewed and discussed the application of **Prinka Perswani**, **MD**, for an initial medical license. Rev. Harman moved that the Committee recommend that the Board grant the applicant a license to practice medicine and surgery in West Virginia. Dr. Dockery seconded the motion, and the motion carried.

The Committee reviewed and discussed the application of **Joyce Bei Foryoung**, **MD**, for an initial medical license. Dr. Dockery moved that the Committee recommend that the Board grant the applicant a license to practice medicine and surgery in West Virginia. Dr. Devaraj seconded the motion, and the motion carried.

The Committee reviewed and discussed the application of **Blake Thomas Edwards, MD,** for an initial medical license. Dr. Devaraj moved that the Committee recommend that the Board grant the applicant a license to practice medicine and surgery in West Virginia. Ms. Takubo seconded the motion, and the motion carried.

The Committee reviewed and discussed the application of **Ali Cadili, MD**, for an initial medical license. Dr. Dockery moved that the Committee invite Dr. Cadili to meet with the Committee at its July 13, 2024, meeting. Ms. Takubo seconded the motion, and the motion carried.

The Committee reviewed and discussed the application of **Martin Phillip Kasofsky, MD**, for an initial medical license. Rev. Harman moved that the Committee recommend that the Board grant the applicant a license to practice medicine and surgery in West Virginia. Ms. Takubo seconded the motion, and the motion carried.

The Committee reviewed and discussed the application of **Eric Hideo Nakanishi**, **MD**, for an initial medical license. Ms. Takubo moved that the Committee recommend that the Board grant the applicant a license to practice medicine and surgery in West Virginia. Dr. Dockery seconded the motion, and the motion carried. The Committee reviewed and discussed the application of **Janelle Ann Thomas**, **MD**, for an initial medical license. Ms. Takubo moved that the Committee recommend that the Board grant the applicant a license to practice medicine and surgery in West Virginia. Rev. Harman seconded the motion, and the motion carried.

The Committee reviewed and discussed the application of **Stella Elizabeth Hines**, **MD**, for an initial medical license. Dr. Dockery moved that the Committee invite Dr. Hines to meet with the Committee at its July 13, 2024, meeting. Ms. Takubo seconded the motion, and the motion carried.

The Committee reviewed and discussed the application of **John Warren Rogers**, **MD**, for initial medical licensure. Rev. Harman moved that the Committee recommend that the Board grant the applicant a license to practice medicine and surgery in West Virginia. Dr. Devaraj seconded the motion, and the motion carried.

The Committee reviewed and discussed the application of **Eyad Khabbaz, MD**, for medical school faculty licensure. Ms. Takubo moved that the Committee communication with the applicant concerning the eligibility requirements for medical school faculty licensure and, if he remains interested in proceeding upon his application, invite Dr. Khabbaz to meet with the Committee at its July 13, 2024, meeting. Dr. Dockery seconded the motion, and the motion carried.

The Committee received and reviewed the following applicant lists for individuals whose applications did not require appearances or individualized discussions:

- 1. One hundred and forty-one initial medical licensure applicants;
- 2. One administrative medicine license applicant; and
- 3. Five initial podiatric licensure applicants.

Copies of these three lists are attached to these minutes and incorporated herein by reference as Attachments 1, 2 and 3. Members of the Committee reviewed the lists for conflicts. No conflicts having been declared:

- Ms. Takubo moved that the Committee approve the list of initial medical licensure applicants and recommend that the Board grant each applicant a license to practice medicine and surgery in West Virginia. Rev. Harman seconded the motion, and the motion carried.
- 2. Ms. Takubo moved that the Committee approve the administrative medicine license application presented and recommend that the Board grant the applicant an administrative medicine license. Dr. Dockery seconded the motion, and the motion carried.
- 3. Rev. Harman moved that the Committee approve the five podiatric applicants and recommend that the Board grant each applicant a license to practice podiatric medicine and surgery in West Virginia. Dr. Devaraj seconded the motion, and the motion carried.

IN PROGRESS

Renewal concludes at 4:30 pm EDT on Friday, June 28, 2024. The Committee expressed its appreciation to the licensure analysts and staff for their hard work during this busy renewal season.

The Committee discussed the fact that there are some physicians who currently hold West Virginia medical licenses issued through the Interstate Medical Licensure Compact Commission who are not eligible to renew through the compact process. There are also some physicians who obtained West Virginia medical licensure through the IMLC who are no longer interested in participating in the compact and would be interested in a conversion pathway. Ms. Takubo moved that the Committee authorize staff to communicate with these licenses and provide a pathway to convert their existing licenses to traditional West Virginia medical licenses, which would require the submission of the component parts of an initial license application as the Board only receives core data concerning expedited licensees from the IMLC. Upon receipt of all traditional application components, staff may effectuate the conversion, and physicians who successfully and timely convert may renew through the traditional renewal process. Dr. Dockery seconded the motion, and the motion carried.

The Committee received a petition from **Michael Antonio Reynolds**, **MD** to modify his August 17, 2022, licensure Consent Order. Dr. Dockery moved that the Committee request that the licensee provide additional information concerning his proposed Consent Order amendments. Ms. Takubo seconded the motion, and the motion carried. The Committee will revisit this request at a future meeting, pending receipt of additional information.

There being no further business, Ms. Takubo moved that the meeting be adjourned. **ADJOURNMENT** Dr. Dockery seconded, the motion carried, and the meeting adjourned.
