## **Physician Assistant Committee Meeting Minutes**

## May 18, 2024

The Physician Assistant Committee of the West Virginia Board of Medicine met at 101 Dee Drive, Charleston, West Virginia, on May 18, 2024, at 9:30 am.

With a quorum present, Ms. Takubo called the meeting to order.

CALL TO ORDER

The Committee reviewed the minutes from its March 9, 2024, meeting. Dr. Patel moved that the Committee approve the minutes. Rev. Harman seconded the motion, and the motion carried.

APPROVAL OF MINUTES

At its March 9, 2024 meeting, the Committee reviewed the application of Lemuel Pierre APPLICANTS for an interstate telehealth registration. The applicant attended an international medical school. He has not attended physician assistant school and has never sat for the PANCE. He holds physician assistant licensure in one territory and two states. The Committee invited the applicant to meet with the Committee at today's meeting. Having received the Committee's invitation, the applicant has requested an accommodation to appear on any day of the week other than a Saturday. Consequently, Mr. Pierre's appearance will be rescheduled for the Executive Management Committee meeting in July, with the Committee's chair also participating in the meeting. The Committee expressed its gratitude to the members of the Executive Management Committee for their assistance in granting the applicant's accommodation request.

No conflicts having been declared, Rev. Harman moved that the Committee recommend each of the preceding ten applicants for physician assistant licensure. Dr. Devaraj seconded the motion, and the motion carried.

The Committee received an inquiry from a PA concerning whether special approval **DISCUSSIONS** is required for PAs to perform central venous catheter placement. After discussion, Mr. Wooton moved that staff correspond with the requestor, thanking the PA for the submission of supervised logs and notifying the PA that under the current regulatory process established in the amended Physician Assistants Practice Act, decisions concerning most scope of practice issues, including central venous catheter placement, are determined at the practice level by the health care facility, PA and collaborating physician based upon the education, training and experience of the PA. No additional endorsement or authorization from the Board is required. Rev. Harman seconded the motion, and the motion carried.

The Committee received an update on Interstate Telehealth Registration ("ITR") renewal, which began in February and concluded on March 29, 2024. Twenty-two of twenty-six eligible PAs successfully renewed ITRs this cycle.
