#### **Board Meeting Minutes September 9, 2024**

The West Virginia Board of Medicine met at 9:00 am on Monday, September 9, 2024 at the Board Office.

With a quorum of members present, Dr. Lilly called the meeting to order, and attendance was documented by Ms. Frame.

ANNOUNCEMENTS

In order to minimize interruptions, Dr. Lilly asked all members to silence their cell phones.

Dr. Lilly welcomed and introduced newly appointed member, Kristen D. Statler, MD. Dr. Statler is a surgeon who practices in Morgantown, West Virginia. She was appointed to the Board in July 2024 for a term ending September 30, 2027.

Dr. Lilly reminded members that the November 4, 2024 meeting will begin at 8:30 am to accommodate a scheduled in-service by Ms. Stephanie Loucka, Executive Director of the State Medical Board of Ohio. The in-service will focus on the investigation and evaluation of sexual misconduct complaints and trauma-informed training.

Prior to today's meeting, the draft July 15, 2024 meeting minutes were made available for members to review. Dr. Rahim moved that the meeting minutes be approved as presented. Dr. Dockery seconded the motion, and the motion carried without opposition.

APPROVAL OF MINUTES

Mr. Spangler thanked board and staff members for their commitment and engagement during the weekend committee meetings.

EXECUTIVE DIRECTOR REPORT

Mr. Spangler reported that he will be traveling to Columbus, Ohio in October to provide training for members of the Ohio Medical Board.

Mr. Spangler reported that Administrators in Medicine (AIM) offers several certification programs, and has recently developed a Certified Medical Board Licensing Specialist (CMBLS) Program. Mr. Spangler further reported that Sara J. Fields, Licensure Analyst for providers whose last names begin with the letters A through G, completed the program to become a CMBLS.

Mr. Spangler reported that he will be attending the Administrators in Medicine Fall Workshop, which will be held in conjunction with the Interstate Medical Licensure Compact Commission meeting, in Phoenix, Arizona on November 20-22, 2024. Ms. Alley is pursing becoming a certified medical board executive; she will also be attending the meetings on November 20-22, 2024.

Mr. Spangler reported that the Federation of State Medical Boards Annual Meeting will be held on April 24-26, 2025 in Seattle, Washington. Mr. Spangler encouraged all members who are able to attend to do so.

Dr. Lilly reported that the Executive/Management Committee met yesterday, September 8, 2024. Aster Berhane's initial medical licensure application was transferred from the Licensure Committee to the Executive/Management Committee for consideration at a Sunday meeting. Dr. Berhane appeared before the Committee. The Committee recommended that Dr. Berhane be approved for medical licensure. The motion of the Committee was given by Dr. Lilly, and the motion carried without opposition.

EXECUTIVE / MANAGEMENT COMMITTEE REPORT

Dr. Lilly reported that the Committee reviewed and approved the fiscal reports and purchasing card transactions for June and July 2024. The Board continues to maintain a good financial position.

Dr. Lilly reported that the Committee considered correspondence requesting that the Board acknowledge the 2023 Pediatric and Adult Brain Death / Death by Neurological Criteria Consensus Practice Guidelines. The Committee directed Board staff to thank the requestor for the information and to advise that the Board will share the guidelines with its regulatory partners.

The Committee recommended that the Board establish the following 2025 meeting dates:

January 13, 2025 March 10, 2025 May 5, 2025 July 14, 2025 September 8, 2025 November 10, 2025

The motion of the Committee was given by Dr. Lilly, and the motion carried without opposition.

Dr. Lilly reported that Ms. Amal Khan, who previously served as the licensure analyst for providers whose last names begin with the letters H through O, resigned in August to attend pharmacy school. Ms. Emilie Lloyd, who served as the receptionist and administrative office assistant, transferred to the position that was vacated by Ms. Khan. Ms. Christina McNealy has been hired to serve as the receptionist and administrative office assistant. Ms. McNealy will assume her position on September 23, 2024. The Board wishes Ms. Khan the best in her future endeavors and looks forward to working with Ms. Lloyd and Ms. McNealy in their new roles.

Dr. Lilly reported that in light of the Federation of State Medical Boards report entitled Navigating the Responsible and Ethical Incorporation of Artificial Intelligence (AI) into Clinical Practice, the Committee directed Board staff to further research medical AI standards and regulations in anticipation of developing a position statement in the future.

Dr. Lilly reported that Board staff are working with the West Virginia Purchasing Division to procure a new database and website.

The Committee recommended that the Board accept and ratify the Executive/Management Committee Report. The motion of the Committee was given by Dr. Lilly, and the motion carried without opposition.

Dr. Rahim reported that the Legislative Committee met yesterday, September 8, 2024, at which time Mr. Spangler reported that the Legislative Rule-Making Review Committee approved the agency approved version of the Board's rule W. Va. Code R. § 11-13.1 *et seq.*, as originally filed. The only modification to this rule updates the sunset provision date. The rule will be considered during the 2025 session of the West Virginia Legislature.

Prior to today's meeting proposed bills which would update W. Va. Code § 30-3-1. et seq. and W. Va. Code § 31B-13-1301. et seq. were made available for members to review. A proposed bill which would amend W. Va. Code § 30-1D-1 to establish a new article entitled the Genetic Counselors Practice Act was also made available for members to review. Dr. Rahim asked Mr. Spangler to provide a summary explanation of the three proposed bills. Mr. Spangler reported that the first proposed bill for the Board's consideration relates to the West Virginia Medical Practice Act; specifically, the proposed bill:

- Updates the definition section.
- Modifies the criteria for serving on the Board for both providers and lay members.
- o Permits:
  - The acceptance of Canadian training.
  - The Board to establish circumstances in which the approval of applications and the issuance of licenses and other practice credentials may be delegated to board staff.
  - The use of electronic signatures on licenses and other practice credentials.
- Reorganizes licensure types into two categories:
  - Licenses that require an examination.
  - Special license types.
- o Repeals:
  - Regulation of radiologist assistants.

- Licensure to practice at certain state veterans nursing home facilities.
  - Licensure by endorsement.
  - The issuance of temporary licenses.
  - Language in the medical school faculty section which provides that the Board will accept licensure from a country which has substantially equivalent requirements for licensure as other US states, the District of Columbia, the Commonwealth of Puerto Rico or Canada.

Mr. Spangler reported that during the 2024 regular session of the West Virginia Legislature, a bill which would permit physician assistants to own a Professional Limited Liability Company (PLLC) was introduced but was not passed. The next proposed bill for the Board's consideration would permit physician assistant ownership of PLLCs. Mr. Spangler reported that during the 2024 regular session of the West Virginia Legislature, a bill which would authorize the Board of Medicine to license and regulate genetic counselors was introduced but was not passed. The final proposed bill for the Board's consideration would authorize the Board to license and regulate genetic counselors. The Committee recommended that the Board authorize Board staff to pursue the introduction of each of these bills during the 2025 session of the West Virginia Legislature. The motion of the Committee was given by Dr. Rahim, and the motion carried without opposition.

Dr. Rahim reported that the Committee reviewed a request to modify the medical school faculty provisions of the West Virginia Medical Practice Act to permit medical school faculty licensees a pathway to unrestricted licensure after a period of time. The Committee directed board staff to research this issue more fully and see if a resolution can be reached which protects the integrity of the licensure process and provides more flexibility to medical school faculty licensees to practice within a broader geographical area under certain conditions. The Committee will revisit this issue in November.

Dr. Rahim reported that as part of the report of the West Virginia Performance Evaluation and Research Division (PERD) to the West Virginia Legislature, PERD recommended that the West Virginia Medical Imaging and Radiation Therapy Technology Board of Examiners be consolidated within the Board of Medicine. Board staff will monitor legislation introduced during the 2025 session of the West Virginia Legislature and will report to the Committee if a consolidation bill is introduced.

Dr. Rahim reported that the Committee directed Board staff to explore possible modifications to the regulation of physician assistants to decrease regulatory burdens.

The Committee recommended that the Board accept and ratify the Executive/Management Committee Report. The motion of the Committee was given by Dr. Rahim, and the motion carried without opposition.

Mr. Foster reported that a hearing convened in December 2023 in the matter of *West Virginia Board of Medicine, Petitioner*, v. *Phillip Allen Peterson, MD*, *Respondent*, Complaint No. 22-86-W. On April 12, 2024, the Board entered a Final Decision and Order with regard to this matter. Counsel for Dr. Peterson has filed an appeal to the Intermediate Court of Appeals. The appeal will be ripe for decision after all briefs have been filed by the parties.
