# **CALL TO**

**ORDER** 

Dr. Mullins called the meeting to order.

#### **EXECUTIVE**

**SESSION** Mr. Tipton made a motion that the Public Session be recessed in order to enter into Executive Session pursuant to W. Va. Code § 6-9A-4(b)(4) and (6), and West Virginia Code § 30-3-6 to discuss pre-probable cause disciplinary matters, matters effecting a license, and information that, if disclosed, would constitute an unwarranted invasion of privacy. Dr. Kukkillaya seconded the motion, and the motion carried.

#### **PUBLIC**

**SESSION** The Complaint Committee re-entered Public Session. Dr. Mullins declared a conflict on a pending matter which was referred to the Complaint Committee for possible initiation of a Committee complaint. Dr. Mullins disclosed that his conflict relates to the fact that his personal and professional interactions with the licensee may create an appearance of partiality or bias. Dr. Mullins designated Ms. Mayfield to chair the meeting in his absence and left the meeting room.

Dr. Kukkillaya moved that the Committee initiate Complaint No. 24-102-W. Mr. Tipton seconded the motion, and the motion carried. Having completed the matter in which Dr. Mullins declared a conflict, Dr. Mullins returned to the meeting room for the remainder of the meeting.

# INITIATED COMPLAINTS

Mr. Tipton seconded the motion, and the motion carried.

Dr. Kukkillaya moved that the Committee seek authority from the Board to issue Consent Orders or Amended Consent Orders in five ongoing matters. Mr. Tipton seconded the motion, and the motion carried.

The Committee is currently investigating a complaint regarding Subhash A. Vyas, MD, License No. 12356, Complaint No. 24-94-W, which was initiated based upon a report raising concerns regarding co-prescribing of controlled substances to patients. Dr. Vyas has been licensed in West Virginia since 1980 and has a prior history of discipline with the Board. The Committee's investigation revealed that Dr. Vyas is currently working on a limited basis at an MAT clinic in Williamson, West Virginia, where he regularly prescribes combinations of 2, 3 or 4 controlled substances to many patients that create a risk for respiratory depression. Additionally, there are concerns that Dr. Vyas does not have control of his DEA registration and further that Dr. Vyas may be unable to practice medicine and surgery with reasonable skill and safety due to physical or mental impairment, including deterioration through the aging process that raise associated concerns for patient safety. Dr. Vyas appeared before the Committee today.

The Committee discussed one additional pending complaint and considered whether summary action was warranted. Dr. Kukkillaya moved:

- 1. That the Committee conclude that, based upon Dr. Vyas's appearance and responses to justify that it has concerns for public safety that requires immediate action.
- 2. The Committee also has concern for the mental and physical health of Dr. Vyas and his ability to practice medicine and surgery safely on patients.
- 3. That the Committee determine that Dr. Vyas's continuation in practice constitutes an immediate danger to the health, welfare and safety of the public;
- 4. That the Board be provided with information relating to evidence that the Committee reviewed in reaching their recommendation in this matter; and

- 5. That the Committee recommend that the Board:
- a. Ratify the Complaint Committee's conclusions as reported here today;
- b. Determine that under all the circumstances, for Dr. Vyas' to continue to hold an unrestricted license to practice medicine in the State of West Virginia, constitutes an immediate danger to the health, welfare, and safety of the public;
- c. Conclude, as a matter of law, that such a danger to the public demands extraordinary measures;
- d. In accordance with its statutory mandate to protect the public interest, SUMMARILY SUSPEND the license to practice medicine of Dr. Vyas, license number 12356, in accordance with the provisions of W. Va. Code §30-3-14(k) and W. Va. Code R. §11-3-10.16 (2010); and
- e. Order Dr. Vyas to participate in a mental and physical examination to determine his current fitness to practice medicine and surgery with reasonable skill and safety.

Mr. Tipton seconded the motion, and the motion carried.

**ADJOURNMENT** There being no further business, the Complaint Committee determined by consensus to adjourn.
