c. There were no PA Interstate Telehealth Registration Applications processed in November and December 2024.

Board staff provided an update concerning the PA Compact. The Compact Committees have been meeting regularly, and there is an in-person Rules Committee meeting scheduled for Wednesday, January 29, 2025, in Columbus, Ohio. The American Academy of Physician Associates and the National Commission on Certification of Physician Assistants are both providing generous financial support to the Compact Commission as the system is developed for implementation. The PA Compact will hold an in-person meeting in April in conjunction with the FSMB Annual Meeting. There are roughly 200,000 active PAs practicing in the United States. Roughly ten to fifteen percent are expected to participate in the compact once it is fully operational and once it is enacted by more states. The current goal is for the compact to become operational and issue its first

compact privilege by the end of 2025/beginning of 2026.

Mr. Spangler notified the Committee that renewal begins on February 3, 2025, for physician assistant licensure, PA controlled substance dispensing registration, and PA interstate telehealth registrants. Renewal will end March 31, 2025, at 4:30pm EDT. As of the Committee's Saturday meeting, 1458 PAs are eligible to renew licensure.

There being no further business Dr. Devaraj moved that the meeting adjourn. Dr. Patel **ADJOURNMENT** seconded the motion, and the motion carried. Chair Takubo adjourned the meeting.
