With a quorum present, Dr. Patel called the meeting to order.

**CALL TO
ORDER**

The Committee reviewed the minutes for the November 2, 2024, meeting. Dr. Dockery moved that the Committee approve the minutes. Dr. Yingling seconded the motion, and the motion carried.

**APPROVAL
OF MINUTES**

The Committee reviewed the request of **Ugoala Chikezie Banks, MD**, to withdraw his application for reactivation of an expired medical license. Ms. Takubo moved that the

Committee recommend that the Board grant Dr. Banks' request to withdraw. Dr. Devaraj seconded the motion, and the motion carried.

The Committee reviewed the request of **Gurpoonam Kaur Jatana, MD** to withdraw her application for a restricted license issued in extraordinary circumstances. Rev. Harman moved that the Committee recommend that the Board grant Dr. Jatana's request to withdraw. Ms. Takubo seconded the motion, and the motion carried.

The Committee reviewed the application of **Ihab Babiker Abdalrahman, MD** for initial medical licensure. Dr. Abdalrahman's application was previously reviewed in November 2024, and the Committee placed his application on hold pending receipt of additional information. Dr. Abdalrahman submitted additional information in support of his application related to his recent successful completion of the Fall 2024 Internal Medicine Maintenance of Certification Examination. Dr. Devaraj moved that the Committee recommend that the Board grant Dr. Abdalrahman a license to practice medicine and surgery in West Virginia. Dr. Statler seconded the motion, and the motion carried.

The Committee reviewed the Consent Order of **Michael Antonio Reynolds, MD**, which was entered on August 17, 2022. The Committee was notified that the Board has not received additional documentation in support of Dr. Reynolds' May 2024 Petition to modify the terms of his Consent Order. Dr. Reynolds is due for an annual appearance before the Committee under the terms of the Consent Order. Dr. Dockery moved that Dr. Reynolds be notified that his annual appearance will be scheduled for March 8, 2025. Dr. Dockery further moved that the licensee be notified that if he wishes to raise the matter of his Petition during his appearance, that he will need to ensure that the information previously requested by the Committee is submitted by February 18, 2025. Mr. Wooton seconded the motion, and the motion carried.

The Committee reviewed and discussed the application of **Raymond Dale Greaser, MD**, for initial medical licensure. Dr. Statler moved that the Committee recommend that the Board grant Dr. Greaser a license to practice medicine and surgery in West Virginia. Dr. Dockery seconded the motion, and the motion carried.

The Committee reviewed and discussed the application of **Donald Wayne Jenkins, MD**, for initial medical licensure. Ms. Takubo moved that the Committee request that Dr. Jenkins appear before the Committee at its March 2025 meeting. Dr. Dockery seconded the motion, and the motion carried.

The Committee reviewed and discussed the application of **Raffaele Borriello, MD**, for initial medical licensure. Dr. Devaraj moved that the Committee request that Dr. Borriello appear before the Committee at its March 2025 meeting. Rev. Harman seconded the motion, and the motion carried.

The Committee reviewed and discussed the application of **Denise Tandjeu Tandjeu, MD**, for initial medical licensure. Dr. Statler moved that the Committee recommend that the Board grant Dr. Tandjeu a license to practice medicine and surgery in West Virginia. Dr. Dockery seconded the motion, and the motion carried.

The Committee reviewed and discussed the application of **Ikshvanku Amrutlal Barot, MD**, for initial medical licensure. Dr. Statler moved that the Committee recommend that the Board grant Dr. Barot a license to practice medicine and surgery in West Virginia. Dr. Devaraj seconded the motion, and the motion carried.

The Committee reviewed and discussed the application of **Vaughan Robert Cipperly, MD**, for initial medical licensure. Dr. Devaraj moved that the Committee recommend that the Board grant Dr. Cipperly a license to practice medicine and surgery in West Virginia. Mr. Wooton seconded the motion, and the motion carried.

The Committee reviewed and discussed the application of **Joseph Alfred Enfonde, MD**, for initial medical licensure. Dr. Devaraj moved that the Committee request that Dr. Enfonde appear before the Committee at its March 2025 meeting. Dr. Yingling seconded the motion, and the motion carried.

The Committee reviewed and discussed the application of **John James Holmes, MD**, for initial medical licensure. Ms. Takubo moved that the Committee recommend that the Board grant Dr. Holmes a license to practice medicine and surgery in West Virginia. Dr. Dockery seconded the motion, and the motion carried.

The Committee reviewed and discussed the application of **Patrick Desmond Kavanagh, MD**, for initial medical licensure. Dr. Statler moved that the Committee recommend that the Board grant Dr. Kavanaugh a license to practice medicine and surgery in West Virginia. Dr. Devaraj seconded the motion, and the motion carried.

The Committee reviewed and discussed the application of **Steven Michael Koenig, MD**, for initial medical licensure. Dr. Devaraj moved that the Committee accept Dr. Koenig's graduate medical education as satisfactorily verified and recommend that the Board grant Dr. Koenig a license to practice medicine and surgery in West Virginia. Rev. Harman seconded the motion, and the motion carried.

The Committee received and reviewed the following applicant lists for individuals whose applications did not require appearances or individual discussions:

1. Seventy-six initial medical licensure applicants;
2. One initial administrative medicine licensure applicant; and
3. Two initial podiatric medical licensure applicants.

Copies of these lists are attached to these minutes and incorporated herein by reference as **Attachments 1, 2 and 3**. Members of the Committee reviewed the lists for conflicts. With no conflicts declared, Ms. Takubo moved that the Committee approve the list of initial

medical licensure applicants and recommend that the Board grant each applicant a license to practice medicine and surgery in West Virginia. Dr. Statler seconded the motion, and the motion carried. Mr. Wooton moved that the Committee approve the administrative medicine license application presented and recommend that the Board grant the applicant an administrative medicine license. Ms. Takubo seconded the motion, and the motion carried. Mr. Wooton moved that the Committee approve the two podiatric medicine license applications presented and recommend that the Board grant the applicants podiatric licensure. Dr. Statler seconded the motion, and the motion carried.



Additionally, physicians whose last names begin with the letters M through Z, related controlled substance dispensing registrations, and all podiatric physicians will renew beginning in May.
