With a quorum of members present, Dr. Lilly called the meeting to order.

CALL TO ORDER

ANNOUNCEMENTS

In order to minimize interruptions, Dr. Lilly asked all members to silence their cell phone.

Dr. Lilly announced that in January 2025 Sherri A. Young, DO, MBA, FAAFP, who was the Cabinet Secretary for the West Virginia Department of Health, was appointed to serve as Secretary of the Board of Medicine until a State Health Officer was appointed by incoming Governor Patrick A. Morrisey. Dr. Young attended the January 2025 meetings, and soon thereafter a successor was named. The Board appreciates Dr. Young's brief tenure on the Board. The Board will recognize Dr. Young with a Certificate of Appreciation.

Dr. Lilly announced that Peter S. Martin, MD has been appointed to serve as interim State Health Officer. As such, Dr. Martin serves as Secretary of the Board. The Board looks forward to working with Dr. Martin.

Prior to today's meeting, the draft January 13, 2025 meeting minutes were made available for members to review. Dr. Kukkillaya moved that the January 13, 2025 meeting minutes be approved as presented. Dr. Dockery seconded the motion, and the motion carried without opposition.

APPROVAL OF MINUTES

Dr. Martin joined the meeting at this time via teleconference.

Mr. Spangler thanked board and staff members for their commitment and engagement during the weekend committee meetings.

EXECUTIVE DIRECTOR REPORT

Mr. Spangler reported that the Administrators in Medicine and the Federation of State Medical Board's Annual Meeting will be held in Seattle Washington on April 21-27, 2025. Mr. Spangler, Ms. Alley, Dr. Lilly and staff member Sara J. Fields will be attending the meetings.

EXECUTIVE /
MANAGEMENT
COMMITTEE
REPORT

Dr. Lilly reported that the Executive/Management Committee met yesterday, March 9, 2025, at which time the Committee received a report from P. Bradley Hall, MD, Executive Director of the West Virginia Medical Professionals Health Program (WVMPHP), regarding the program's budget and funding. Kenneth Dean Wright, PA, who is a former member of the Board of Medicine and who now serves on the WVMPHP Board accompanied Dr. Hall. The Board appreciates the important contribution that the WVMPHP makes to physician wellness and public safety. The Board thanks Dr. Hall and Mr. Wright for providing the report.

Dr. Lilly reported that the Committee reviewed and approved the fiscal reports and purchasing card transactions for December 2024 and January 2025. The Board continues to maintain a good financial position.

Dr. Lilly reported that the Committee considered two inquiries referred at the request of the West Virginia Secretary of State's Office relating to the naming of corporate entities. The first entity, ACC Psychiatry LLC, is a company that is currently authorized in Maryland. The owner, who is a certified registered nurse practitioner who specializes in psychiatric mental health, is licensed in Maryland and West Virginia and is providing psychotherapy and medication management services via telehealth in his solo psychiatric practice. He is seeking to foreign qualify his company in West Virginia. The second entity, Urgent Care Radiology Insights LLC, is owned by a radiologic technologist who also holds the credentials of MBA and CRA. This entity is seeking to provide consulting services to urgent care facilities on radiology workflows, efficiency, educational programs, etc. The Committee directed Board staff to advise the requesting companies and the West Virginia Secretary of State's Office that the Board is not in a position to endorse the use of the proposed names, as the names may be misleading to the public.

Dr. Lilly reported that since 1992, the Board has provided data to the West Virginia University Office (WVU) of Health Services Research, and the said office has assisted in processing requests for Board of Medicine data. In response to legislation that was enacted, the Board is required to publish rosters which contain the name, credential number and credential expiration date on the Board's website. Board staff anticipate that if the cohort

of publicly available information that is published on the website is expanded, that the number of requests which require data to be generated on a case-by-case basis will decrease, which would permit Board of Medicine staff to process all requests in-house. The Committee authorized Board staff to expand the publicly available information that is published on the rosters and to notify the WVU Office of Health Services Research that the Board appreciates their assistance with processing requests; however, in the future the Board will process all requests for Board of Medicine data.

Dr. Lilly reported that the Committee reauthorized the Board's Application Review Workgroup to evaluate current applications and determine whether any modifications and/or modernizations are needed.

Dr. Lilly reported that the Committee carefully considered the Board's Telework Program. The Committee recommended that the Board rescind the Board's Telework Program and confirm that the rescission of the Telework Program reverts the Board to its pre-COVID-19 practice of granting the Executive Director discretion to permit temporary or intermittent remote work under extenuating circumstances and where the practice would support the mission of the Board. The motion of the Committee was given by Dr. Lilly, and the motion carried without opposition.

Dr. Lilly reported that the Committee received an update on the status of the PA Licensure Compact (PA Compact) and the Interstate Podiatric Licensure Compact (IPLC). The PA Compact is enacted and moving forward; the IPLC is proceeding in the drafting phase. Both compacts are moving forward.

Dr. Lilly reported that the Committee received an update from staff regarding 2025 renewals. Renewal information will be provided later this morning as part of the Physician Assistant Committee and Licensure Committee Reports.

Dr. Lilly reported that Board staff continue to work with the West Virginia Purchasing Division to procure a new database and website.

Dr. Lilly reported that Ms. Bonnie L. McClure, who served as the Receptionist/Administrative Office Assistant, is no longer employed by the Board. Ms.

Angela L. Hunt has been hired to fill the Receptionist/Administrative Office Assistant position. The Board wishes Ms. McClure the best in her future endeavors and looks forward to working with Ms. Hunt.

The Committee recommended that the Board accept and ratify the Executive/Management Committee Report. The motion of the Committee was given by Dr. Lilly, and the motion carried without opposition.

Dr. Sheth reported that the 2025 session of the West Virginia Legislature convened on February 12, 2025, and will conclude on April 12, 2025. The Legislative Committee met on February 26, 2025 and yesterday, March 9, 2025.

LEGISLATIVE COMMITTEE REPORT

Dr. Sheth reported that the Board's legislative rule W. Va. Code R. § 11-13-1 et. seq., Waiver of Initial Licensing Fees for Certain Initial Licensure Applicants, which updates the sunset provision from August 2025 to August 2030 has passed the Senate and is awaiting consideration by the House Government Organization Committee.

Dr. Sheth reported that the following bills are being closely monitored by Board staff:

- Senate Bill 29, which is the Board's bill that would permit physician assistants to own foreign medical corporations and professional limited liability companies.
- Senate Bill 86, which creates an Unmatched Medical Graduate Advisory Council.
- Senate Bill 115, which establishes a tax credit for certain physicians who locate to practice in West Virginia.
- Senate Bill 117, which exempts certain physicians from traffic laws when
 responding to emergencies. This bill would require the Board of Medicine and the
 Board of Osteopathic Medicine to promulgate rules and set fees to implement the
 authorization.
- Senate Bill 159, which would add a new section to the West Virginia Medical Practice Act that would prohibit medical providers from performing pelvic, prostate, rectal and breast exams on sedated or unconscious patients. As written,

the bill would limit the Board from revoking a license if it desired to do so and it does not address who would collect the fine. Board staff are seeking an amendment to this bill to provide clarity and more discretion to the Board with regard to the disciplinary and sanction provisions.

- Senate Bill 167, which is intended to allow the practice of telemedicine across state lines and attempts to do so by reinstating COVID-19-era practice standards. Mr. Spangler has explained to the bill sponsor that the Board has an interstate telehealth registration process in place which permits telemedicine practice. The Committee is opposed to Senate Bill 167.
- Senate Bills 177 and 526, which would permit pharmacists to prescribe medications to patients under certain circumstances. The Committee is opposed to these bills.
- Senate Bill 204, which as originally introduced, would make opioid treatment programs unlawful. The Committee did not support this bill. A committee substitute has modified the bill to permit treatment programs but requires that they transition to an integrated care model on or before July 1, 2026. The committee substitute also includes rulemaking authority for the West Virginia Office of Drug Control Policy.
- Senate Bill 248, which would modify the Opioid Reduction Act to require practitioners to inform the patient of nonopioid alternatives and to provide patients with an educational pamphlet regarding the use of prescription nonopioid alternatives prior to issuing a prescription for a Schedule II controlled substance.
- Senate Bill 263, which modifies the general provisions governing how licensing boards can consider criminal convictions in the context of licensing. The Board is carved out of this section of code except for a new provision that prohibits asking about or considering pending criminal charges during the application and licensing process. The Committee has directed Board staff to pursue a carve out from this section as well.
- Senate Bill 458 and House Bill 2001, which were introduced at the request of the Governor. These bills would provide for a universal licensing process for persons licensed in another state and who establish a residence in West Virginia and certain

military spouses. As introduced, the Committee had significant concerns with Senate Bill 458; however, the bill has been amended to provide that physicians, osteopathic physicians and podiatric physicians must have completed accredited training to be eligible for this license type.

- Senate Bill 557, which is the Board's bill that would modify the West Virginia Medical Practice Act and permit the Board to license and regulate genetic counselors. This bill has not yet been placed on an agenda.
- Senate Bill 565 and House Bill 2975, which would allow optometrists to perform ophthalmic laser procedures. Senate Bill 565 has been amended to require "a training requirement that at least 10 of each new procedure must be supervised for a total of 50 collective cases for each individual person proposing certification shall be proctored by an optometrist or ophthalmologist that already meets the above criteria". The Committee opposes these bills.
- Senate Bill 660 and House Bill 2544, which would permit qualified physician assistants and nurse practitioners to practice without the supervision of a physician. Specifically, the bill would eliminate the definition of "collaborating" and "collaborating physician"; and prohibit the Board from proposing any rule that would require physician supervision of physician assistants. The Committee opposes these bills.
- House Bill 2631, which would require all medical providers to orally explain any
 and all medical treatments and procedures and all possibilities or potential
 problems, complications or side effects to patients before treatment. The bill would
 also authorize the Board of Medicine to impose an administrative fine for failing to
 comply with the statute. The Committee opposes this bill.
- House Bill 2672, which would modify the West Virginia Medical Practice Act to require all hospitals or medical offices to send a notice to all former or current patients when they turn 18 informing them that if they had any negative or adverse side effects of a procedure that was performed on them as a child to contact the hospital or office and inform them of the issue. The Committee opposes this bill.
- House Bill 3222, which would require doctors that grant medical cannabis cards to have a physical office within West Virginia. The Committee is in favor of this bill.

• House Bill 3261, which relates to the administration of anesthetics by certified registered nurse anesthetist (CRNA). This bill provides that the anesthesia may be provided by a CRNA in cooperation with a physician, a dentist, a podiatrist, an advanced practice registered nurse and/or a physician assistant. A similar bill, Senate Bill 43, which would permit a CRNA to administer anesthetics in cooperation with a physician or dentist. The Committee prefers the Senate Bill 43, which does not include podiatrists, advanced practice registered nurses or physician assistants.

Dr. Sheth reported that the Committee recommended that the Board delegate authority to the Committee to continue to act on behalf of the Board as necessary to respond to legislative matters during the 2025 legislative session. The motion of the Committee was given by Dr. Sheth, and the motion carried without opposition.

The Committee recommended that the Board accept and ratify the Legislative Committee Report. The motion of the Committee was given by Dr. Sheth, and the motion carried without opposition.

Ms. Alley reported that the Intermediate Court of Appeals affirmed the Board's Order in the matter of *West Virginia Board of Medicine, Petitioner*, v. *Phillip Allen Peterson*, *MD*, *Respondent*, Complaint No. 22-86-W. Ms. Alley acknowledged the exemplary performance of Mr. Foster in handling this matter.

Ms. Takubo reported that there were no physician assistant interstate telehealth registration applications processed in January and February 2025.

Ms. Takubo reported that the Committee received an update from Board staff regarding the status of the PA Licensure Compact. The process of establishing rules, entering into memoranda of understanding and developing communication packets for new states who will be onboarding are in process. The PA Compact Commission will hold an in-person meeting in Seattle, Washington on April 25, 2025 in conjunction with the Federation of State Medical Board's Annual Meeting.

Ms. Takubo reported that the Committee discussed pending legislation which affects the physician assistant profession, all of which were reported earlier today as part of the Legislative Committee Report.

Ms. Takubo reported that the Committee received an update from Board staff regarding 2025 physician assistant renewal. As of Saturday, March 8, 2025, 840 of 1477 eligible physician assistants have successfully renewed their license. Eight of 29 eligible physician assistant interstate telehealth registrants have successfully renewed their registrations. Seventeen of 58 physician assistants have also successfully renewed their controlled substance dispensing registration. The 2025 physician assistant renewal period concludes at 4:30 pm on March 31, 2025.

The Committee recommended that the Board accept and ratify the Physician Assistant Committee Report. The motion of the Committee was given by Ms. Takubo, and the motion carried without opposition.

Dr. Patel reported that the Committee met on Saturday, March 8, 2025, at which time two of the four scheduled physicians appeared before the Committee. Dr. Patel further reported that on August 17, 2022, Michael Antonio Reynolds, MD and the Board entered into a Consent Order which issued Dr. Reynolds a medical license and restricted his practice in West Virginia to the specialty of addiction medicine with additional terms and conditions, including a period of probation and the submission of controlled substance prescribing logs. Dr. Reynolds appeared before the Committee on Saturday for an annual appearance pursuant to the terms of his Consent Order. No action is required at this time. The Committee will continue to monitor the Consent Order.

Ms. Mayfield reported that on August 15, 2024, Jacob Andrew Young, MD entered into a Consent Order with the Board and has been compliant with the terms and conditions of his probation. Dr. Young has petitioned the Board to modify the Consent Order and lift the probationary status. The Committee recommended that the Board enter an Order terminating Dr. Young's Consent Order. The motion of the Committee was given by Ms. Mayfield, and the motion carried without opposition.

Ms. Mayfield reported that the Complaint Committee of the Board is currently conducting an investigation with respect to a physician that includes allegations of unprofessional conduct related to substance use and/or misuse. W. Va. Code § 30-3-14(f) provides as follows: "The investigating body (Complaint Committee) ... may request and the board under any circumstances may require a physician ... to submit to a physical and mental examination, by a physician or physicians approved by the board." In connection with its current investigation, and pursuant to West Virginia Code § 30-3-14(f), the Complaint Committee requested that the Board authorize the issuance of an Order requiring the subject

physician to submit to a complete mental and physical examination, including drug testing, by a physician or physicians approved by the Board. The motion of the Committee was given by Ms. Mayfield, and the motion carried without opposition.

The Committee recommended that the Board accept and ratify the Complaint Committee Report. The motion of the Committee was given by Ms. Mayfield, and the motion carried without opposition.
