With a quorum of members present, Dr. Lilly called the meeting to order.

ORDER**

In order to minimize interruptions, Dr. Lilly asked all members to silence their cell phone.

ANNOUNCEMENTS

Dr. Lilly welcomed former board member, Matthew Q. Christiansen, MD, MPH, to the meeting and presented him with a plaque in recognition of this outstanding dedication and service made to the Board and in appreciation of his commitment to protecting the quality and safety of medical and podiatric care for the citizens of West Virginia. The Board wishes Dr. Christiansen the best in his future endeavors.

Dr. Lilly welcomed and introduced staff member Ms. Angela Hunt. Ms. Hunt has served as administrative office assistant / receptionist since March 2025; her contributions have already made her a valued staff member.

Dr. Lilly congratulated Ms. Alley on obtaining her certification as a Medical Board Executive. The Board is fortunate to have Ms. Alley as a member of the staff – her dedication and expertise continue to strengthen the agency.

Dr. Lilly reported that the Federation of State Medical Board's Annual Meeting was held in Seattle Washington on April 21-27, 2025. Mr. Spangler, Ms. Alley and Dr. Lilly attended the meeting. The 2026 FSMB Annual meeting will be held on April 30 – May 2, 2026 in Baltimore, Maryland. Dr. Lilly encouraged all members who are able to attend to do so.

Prior to today's meeting, the draft March 10, 2025 meeting minutes were made available for members to review. Dr. Kukkillaya moved that the March 10, 2025 meeting minutes be approved as presented. Dr. Patel seconded the motion, and the motion carried without opposition.

Mr. Spangler reported that Administrators in Medicine offers several certification programs. He further reported that the following staff members have obtained certification and/or recertification through an AIM program:

Dr. Lilly reported that the Executive/Management Committee met yesterday, May 4, 2025, at which time the Committee reviewed and approved the fiscal reports and purchasing card transactions for February and March 2025. The Board continues to maintain a good financial position.

Dr. Lilly reported that the Committee considered two inquiries referred at the request of the West Virginia Secretary of State's Office related to the naming of corporate entities. The Committee directed Board staff to advise the requesting entities and the West Virginia Secretary of State's Office that the Board does not oppose the business names so long as the entities do not engage in any activities that constitute the practice of medicine.

Dr. Lilly reported that the Committee reviewed two inquiries which Mr. Spangler has referred to the West Virginia Board of Pharmacy. The first inquiry related to the use of

GLP-1 receptor agonists which are being split and administered in a medical office setting. The second inquiry related to automated dispensing of medications.

Dr. Lilly reported that the Committee reviewed correspondence concerning allegation of the unauthorized practice of medicine. In advance of today's meeting, a copy of the correspondence was made available for members to review. The Committee recommended that the Board authorize staff to investigate the allegations set forth in the correspondence, with full investigative authority, in order to assist the Committee in making a determination as to what, if any, steps need to be taken to ensure public protection. The motion of the Committee was given by Dr. Lilly, and the motion carried without opposition.

Dr. Lilly reported that W. Va. Code R. § 11-9-1 *et seq.*, *Certification, Disciplinary and Complaint Procedures, Continuing Education, Radiologist Assistants*, which became effective July 1, 2008, authorizes the Board of Medicine to issue a certification to individuals that the Board approves to serve as a radiologist assistant. To date, the Board has not issued a certification for this credential type. The West Virginia Medical Imaging & Radiation Therapy Technology Board of Examiners has inquired whether the Board of Medicine is amenable to introducing legislation to transfer the regulation of radiologist assistants to the said Board. The Committee recommended that the Board take the position that since the Board has never issued a certification for a radiologist assistant there may be no particularized need for this professional credential particular, and that the Board does not oppose eliminating regulation of this credential type or transferring regulation of this credential type to the West Virginia Medical Imaging & Radiation Therapy Technology Board of Examiners. The motion of the Committee was given by Dr. Lilly, and the motion carried without opposition.

Dr. Lilly reported that the Committee received an update from Board staff regarding renewals. A renewal update will be provided later this morning as part of the Physician Assistant Committee and Licensure Committee reports.

Dr. Lilly reported that the Committee reviewed the following Executive Orders that were issued by Governor Patrick J. Morrisey and the Board's response thereto:

- Establishing an Economic Backyard Brawl;
- Ordering Cessation of Diversity, Equity and Inclusion;
- Reviewing Past, Present and Projected Spending Decisions;
- Directing Agencies to Develop a Plan for More Efficient Government; and
- Plan to Reduce Rules, Regulatory Review.

In advance of today's meeting, a copy of the Executive Orders and the Board's response thereto was made available for members to review.

Dr. Lilly reported that the Committee received an update from Board staff in the matter of *West Virginia Board of Medicine, Petitioner, v. Phillip Allen Peterson, MD, Respondent*, Complaint No. 22-86-W. An update regarding this matter will be provided later this morning as part of the Board Attorney Report.

Dr. Lilly reported that the Committee received an update from Board staff regarding the Physician Assistant Licensure Compact, which has been activated and is in the processes of becoming operational, and the Podiatric Medical Licensure Compact, which is in the initial process of compact enactment.

Dr. Lilly reported that Board staff continue to work with the West Virginia Purchasing Division to procure a new database and website. Evaluation Committee membership has been established, and the specifications have been drafted and reviewed by the Purchasing Division. The contract with the Board's current database vendor, Big Picture, is scheduled to expire on July 10, 2025; therefore, the Board will need to enter into an extension agreement with the vendor.

The Committee recommended that the Board accept and ratify the Executive/Management Committee Report. The motion of the Committee was given by Dr. Lilly, and the motion carried without opposition.

Dr. Sheth reported that the Legislative Committee met yesterday, May 4, 2025, at which time Mr. Spangler provided an overview of the 2025 session of the West Virginia Legislature which convened on February 12, 2025 and concluded on April 12, 2025.

Dr. Sheth reported that Senate Bill 369, a bundled bill authorizing miscellaneous boards and agencies to promulgate legislative rules, which included proposed amendments to the Board's legislative rule W. Va. Code R. § 11-13-1 *et. seq.*, *Waiver of Initial Licensing Fees for Certain Initial Licensure Applicants*, has completed the legislative process and has been signed by the Governor. The only modification to this rule updates the sunset provision from August 2025 to August 2030. Board staff will file the final version of this rule with the West Virginia Secretary of State's Office.

Dr. Sheth reported that the following bills, which were closely monitored by Board staff, were passed during the 2025 session of the West Virginia Legislature:

- **Senate Bill 458** - This bill provides for a universal licensing process for individuals licensed in another state who establish a residence in West Virginia and certain military spouses. Board staff were successful in getting the bill amended to require that physicians, osteopathic physicians and podiatric physicians must have completed accredited training to be eligible for this type of license. Senate Bill 458 becomes effective on July 1, 2025.
- **Senate Bill 526** - This bill permits pharmacists to prescribe medication, excluding controlled substances, after conducting a waived Clinical Laboratory Improvement Amendments test for influenza, SARS-COV-2, and/or RSV. The bill also permits a pharmacist to refill an expired epinephrine injection device prescription. Additionally, the bill requires pharmacists to notify the patient's primary care physician within 72 hours of conducting a test and prescribing medication. Prescriptions are restricted to a 30-day supply within six months, and if the prescription exceeds 10 days, the pharmacist must inform the primary care physician. If no primary care physician is identified, the pharmacist must

attempt to refer the patient to a primary care physician. Senate Bill 526 becomes effective on July 11, 2025.

- **Senate Bill 565** - This bill permits optometrists who obtain ophthalmic laser utilization certification to perform ophthalmic laser procedures. In addition to educational requirements, to obtain certification the optometrist must satisfactorily complete a set number of proctored procedures on a living human eye to the proctor's satisfaction. Senate Bill 565 becomes effective on July 9, 2025.
- **Senate Bill 810** - This bill permits a Certified Registered Nurse Anesthetist (CRNA) to administer anesthesia in cooperation with a physician, dentist or podiatrist. The bill also clarifies that a CRNA "does not have independent practice authority." Senate Bill 810 becomes effective on July 7, 2025.

Dr. Sheth reported that the following Board of Medicine bills were introduced, but not passed during the 2025 session of the West Virginia Legislature:

- **Senate Bill 29** - This bill would have authorized physician assistants to own foreign medical corporations and professional limited liability companies.
- **Senate Bill 557** - This bill would have made several modifications to the West Virginia Medical Practice Act and would have permitted the Board to license and regulate genetic counselors.

Dr. Sheth reported that in preparation for the 2026 session of the West Virginia Legislature the Committee directed staff to explore alternative licensing models for international medical graduates and make recommendations to the Committee at a future meeting.

Dr. Sheth reported that Board staff will review current rules to determine what, if any, modifications are needed as a result of legislation that was enacted during the 2025 session of the West Virginia Legislature. Additionally, while specific changes are not yet fully developed, the Committee recommended that the Board authorize staff to revise the Board's current continuing education requirements to modernize the nomenclature related to maintenance of certification, and to eliminate the recurrent requirement for a licensee who prescribes, administers and/or dispenses a controlled substance medication to complete a three hour Board-approved course on risk assessment and responsible prescribing of controlled substances every two years as a prerequisite to license renewal. The motion of the Committee was given by Dr. Sheth, and the motion carried without opposition.

Dr. Sheth reported that the deadline to file a Notice of Comment Period with the West Virginia Secretary of State's Office for rules to be considered during the 2026 legislative session is June 25, 2025. The Board will need to authorize all rulemaking prior to the July meeting cycle. The Legislative Committee is prepared to hold interim meetings for this purpose, if authorized to do so by the Board. The Committee moved that the Board grant the Committee authority to act on behalf of the Board with regard to rulemaking for the 2026 legislative session. The motion of the Committee was given by Dr. Sheth, and the motion carried without opposition.

The Committee recommended that the Board accept and ratify the Legislative Committee Report. The motion of the Committee was given by Dr. Sheth, and the motion carried without opposition.

Mr. Foster reported that the Intermediate Court of Appeals affirmed the Board's Order in the matter of *West Virginia Board of Medicine, Petitioner, v. Phillip Allen Peterson, MD, Respondent*, Complaint No. 22-86-W. Dr. Peterson has elected not to appeal this matter to the Supreme Court. He has paid the invoice issued by the Board in this matter.

Ms. Takubo reported that physician assistants whose license expired on March 31, 2025 are eligible to apply for reinstatement of licensure through March 31, 2026. There were no physician assistant reinstatement applications processed in April 2025.

Ms. Takubo reported that the Committee received an update from Board staff regarding the status of the PA Licensure Compact. The PA Compact Commission held its annual meeting on April 25, 2025 in Seattle, Washington. The Compact has received interim funding from its *ex officio* partners, the American Academy of Physician Associates, and the National Commission on Certification of Physician Assistants, which will support the Compact as implementation continues. The Compact has received educational presentations from database providers and will be moving forward with rulemaking throughout the summer.

Ms. Takubo reported that the Committee discussed pending legislation which affects the physician assistant profession, all of which have been reported on earlier today in the Legislative Committee Report. In addition, the Committee considered the current utility of the Practice Notification process in light of legislation considered in the 2025 session and has offered recommendations regarding the elimination of the Practice Notification for the Executive/Management Committee's consideration.

Ms. Takubo reported that the Committee received an update from Board staff regarding 2025 physician assistant renewal. The 2025 physician assistant renewal period concluded at 4:30 pm on March 31, 2025. The following renewal statistics were reported:

Regarding Dr. Taheri, the Committee recommended that the Board make the following findings:

1. Dr. Taheri has exceptional education, training and practice credentials, including:
 - a. Dr. Taheri has achieved a high level of academic, clinical and professional recognition for excellence in endocrinology, obesity, type 2 diabetes and sleep medicine.
 - b. Dr. Taheri received a medical degree from The Medical College of Saint Bartholomew's Hospital, University of London in 1994. In 2003, he was awarded a Ph.D. in neuroendocrinology by Imperial College, University of London. In 2022, Dr. Taheri received a Certificate of Healthcare Management and Executive MBA at HEC Paris-Cornell University.
 - c. Dr. Taheri received general and specialist medical training at various institutions in the United Kingdom, including the University of Bristol and Imperial College of London.
 - d. In 2018, Dr. Taheri received the Paul Dudley White International Scholar Award from the American Heart Association.
 - e. He has significant research experience and has been attached to over \$90 million dollars of research funding. He led a recent clinical trial demonstrating type 2 diabetes remission in patients with early diabetes through weight loss and lifestyle changes.
 - f. Dr. Taheri has authored or co-authored over 190 scholarly, academic and/or scientific publications, with an H-Index of 60.
 - g. Dr. Taheri serves as Editor-in-Chief of Clinical Obesity and has contributed to the World Obesity Federation Strategic Plan 2025-2027.
 - h. Dr. Taheri has served as a member of the Clinical Care Committee of the World Obesity Federation.
 - i. Dr. Taheri has significant experience in senior administrative positions in research, clinical care and medical education.
 - j. Dr. Taheri has extensive clinical and teaching experience. He has supervised multiple students and fellows in PhD/MD

participating in postgraduate fellowship and research. His academic appointments include:

1. Professor of Medicine – Weill Cornell Medicine, Qatar and New York
2. Professor of Epidemiology and Health Services Research and Professor of Integrative Medicine - Weill Cornell Medicine, Qatar and New York
3. Professor of Medicine - University of Leicester, UK
4. Visiting Professor of Medicine – King’s College London, UK
5. Honorary Professor of Medicine - University College of London, UK

2. Dr. Taheri’s practice in the state would be beneficial to public welfare because his practice and research are poised to provide an energetic response to the obesity epidemic in West Virginia.

3. Dr. Taheri’s specialty is in endocrinology, obesity, type 2 diabetes and sleep medicine, and there is a need for his specialty expertise in West Virginia.

4. The applicant’s education, training and practice credentials are substantially equivalent to the requirements of licensure established in W. Va. Code §30-3-10(b). While Dr. Taheri’s education and training occurred outside of the United States and are not, standing alone, substantially equivalent to the licensure requirements in this state, his education and training, in association with his superior research, extensive clinical experience and scholarship satisfy this requirement.

5. Dr. Taheri has no professional discipline which would render him ineligible for an extraordinary circumstances license.

6. Dr. Taheri is eligible for a restricted license in extraordinary circumstances.


