**CALL TO
ORDER**

Ms. Mayfield called the meeting to order.

MINUTES Dr. Kukkillaya made a motion to approve the minutes of the January 12, 2025 Complaint Committee meeting, the January 31, 2025 special meeting and the February 18, 2025 Emergency Complaint Committee meeting. Mr. Tipton seconded the motion, and the motion carried.

COUNSEL REPORT

Mr. Foster provided an update with respect to the Consent Orders offered by the Committee. Since the January meeting, a fully executed Consent Order has been entered with respect to the following licensee:

EXECUTIVE

SESSION Dr. Kukkillaya made a motion that the Public Session be recessed in order to enter into Executive Session pursuant to W. Va. Dr. Mullins disclosed that his conflict relates to the fact that his personal interactions with the licensee may create an appearance of partiality or bias. Dr. Mullins then exited the meeting room.

Mr. Tipton moved that the Committee close Complaint No. 24-91-W. Dr. Kukkillaya seconded the motion, and the motion carried. Having completed the matter in which Dr. Mullins declared a conflict, Dr. Mullins returned to the meeting room for the remainder of the meeting.

Mr. Tipton declared a conflict with regard to Complaint No. 24-11-W. Mr. Tipton disclosed that his conflict relates to the fact that he and the licensee are former co-workers. Mr. Tipton then exited the meeting room.

Dr. Kukkillaya moved that the Committee authorize the presentation of a Consent Order with regard to Complaint No. 24-11-W. Dr. Mullins seconded the motion, and the motion carried. Having completed the matter in which Mr. Tipton declared a conflict, Mr. Tipton returned to the meeting room for the remainder of the meeting.

Dr. Kukkillaya seconded the motion, and the motion carried.

Mr. Tipton moved that the Committee seek authority from the Board to issue Consent Orders or Amended Consent Orders in three ongoing matters. Dr. Kukkillaya seconded the motion, and the motion carried.

On August 15, 2024, Jacob Andrew Young, MD, entered into a Consent Order with the Board. Dr. Young has petitioned the Board to modify the Consent Order and lift the probationary status. The licensee has been compliant with the terms and conditions of his probation. Mr. Tipton moved that the Committee recommend that the Board enter an Order terminating Dr. Young's Consent Order. Dr. Kukkillaya seconded the motion, and the motion carried.

The Complaint Committee of the Board is currently conducting an investigation concerning a physician that includes allegations of unprofessional conduct related to substance

abuse and/or misuse, in connection with its current investigation, and pursuant to the West Virginia Code § 30-3-14(f), Mr. Tipton moved that the Complaint Committee now request that the Board authorize the issuance of an Order requiring "Physician A" to submit to a complete mental and physical examination, including drug testing, by a physician or physicians approved by the Board. Dr. Kukkillaya seconded the motion, and the motion carried.

ADJOURNMENT There being no further business, the Complaint Committee determined by consensus to adjourn.
