Call to Order

With a quorum of members present, **Ms. Mayfield** called the meeting to Order

Approval of Minutes

Chief Disciplinary Counsel Foster provided an update with respect to Consent Orders previously offered by the Committee. Since the July meeting, the following Consent Orders have been executed and entered:

Jonathan Shanley Parker, PA Complaint No. 23-120-E	July 14, 2025	This expired licensee was publicly reprimanded for providing inadequate and deficient care to an emergency room patient. He is also prohibited from reinstating or reactivating his expired license until he complies with certain terms and conditions
Mark Allen Harris, PA Complaint No. 25-41-W	August 26, 2025	This licensee was publicly reprimanded for his unprofessional conduct in performing DOT physicals after the expiration of his certification as a FMCSA Certified Medical Examiner.
Anthony Joseph Parravani, MD Complaint No. 25-32-W	August 26, 2025	This licensee was disciplined for engaging in sexual misconduct with a patient. He was publicly reprimanded, placed on probation for a minimum period of one year, and required to undergo a multidisciplinary assessment and evaluation at the Professional Renewal Center.
Kamalesh Purushottam Patel, MD Complaint No. 25-43-W	August 26, 2025	This licensee was fined \$500.00 for administering Midazolam in his office to patients without registering as a controlled substance dispensing practitioner.

Complaint Committee Activity

Dr. Mullins moved that the public session be recessed in order to enter into executive session pursuant to W. Va. Code § 6-9A-4(b)(4) and (6), and W. Va. Code § 30-3-6 to discuss pre-probable cause disciplinary matters, matters effecting a license, and information that, if disclosed, would constitute an unwarranted invasion of privacy. **Dr. Kukkillaya** seconded the motion, and the motion carried.

Complaint Committee Actions and Recommendations

Authorization to Offer Consent Orders

Mr. Tipton moved that the Committee seek authority from the Board to issue Consent Orders or Amended Consent Orders in **three** ongoing matters. **Dr. Statler** seconded the motion, and the motion carried.

Complaint Committee Actions and Recommendations

⁴ **Dr. Statler** declared a conflict with respect to this pending matter, which was referred to the Complaint Committee for possible initiation of a Committee complaint. **Dr. Statler** disclosed that her conflict relates to the fact that she participated in the reporting entity's investigation of the licensee at the peer review level and her professional interactions related therewith may create an appearance of partiality or bias. She was absent for the entirety of the discussion and action concerning this matter and returned to the meeting after the vote concluded.

⁵ **Dr. Mullins** declared a conflict with respect to this pending matter, which was referred to the Complaint Committee for possible initiation of a Committee complaint. **Dr. Mullins** disclosed that his conflict relates to the fact that he is the Chief of Medical Staff at Princeton Community Hospital, and in that capacity is familiar with some of the facts and circumstances which formed the basis of the report, and his professional interactions related thereto and with respect to the licensee may create an appearance of partiality or bias. He was absent for the entirety of the discussion and action concerning this matter and returned to the meeting after the vote concluded.

Request for Order Requiring Licensee to Undergo Mental/Physical Examination

The Complaint Committee of the Board is conducting a confidential investigation with respect to a physician as part of its evaluation of a pending complaint. The physician appeared before the Committee at its September 7, 2025, meeting, during which the physician's appearance and responses to questioning by the Committee gave rise to concern on the part of the Committee for the physician's current health and fitness to practice medicine with reasonable skill and safety.

W. Va. Code § 30-3-14(f) authorizes the Complaint Committee to request "and the board under any circumstances may require a physician ... to submit to a physical and mental examination, by a physician or physicians approved by the board."

In connection with its current investigation, and pursuant to West Virginia Code § 30-3-14(f), **Mr. Tipton** moved that the Complaint Committee recommend that the Board issue an order requiring the subject physician to submit to a complete mental and physical examination by a physician or physicians approved by the Board. **Dr. Statler** seconded the motion, and the motion carried.

Adjournment

There being no further business to consider, the Complaint Committee determined by consensus to adjourn.
