Call to Order

With a quorum of members present, and in the absence of Dr. Lilly, Ms. Takubo called the meeting to order.

Announcements

In the absence of Dr. Lilly, Ms. Takubo chaired today's meeting.

In order to minimize interruptions, Ms. Takubo asked members to silence their cell phones.

Ms. Takubo welcomed and introduced Mark E. McDaniel, DO. Dr. McDaniel was appointed as acting West Virginia State Health Officer in August 2025, and as such he serves as Secretary of the Board of Medicine. The Board looks forward to working with Dr. McDaniel, who is the second osteopathic physician to serve on this Board.

Dr. McDaniel succeeds Peter S. Martin, MD, who served as Interim State Health Officer from February 2025 to August 2025. The Board appreciates Dr. Martin's service to the Board and wishes him all the best in his future endeavors.

Approval of Minutes

Prior to today's meeting, a copy of the draft July 14, 2025 meeting minutes were made available for members to review. Dr. Statler moved that the July 14, 2025 meeting minutes be approved as presented. Dr. Devaraj seconded the motion, and the motion carried without opposition.

Executive Director's Report

Mr. Spangler thanked board and staff members for their commitment during the weekend committee meetings.

Mr. Spangler reported that the supervisor of the Licensure, Certification and Renewals Division, Sheree J. Thompson, and licensure analyst, Carmella L. Walker, will be attending the Administrators in Medicine meeting in Portland, Oregon on September 18-19, 2025 where they will finalize the requirements necessary to become a Certified Medical Board Licensing Specialist.

Executive / Management Committee Report

Fiscal Reports and Purchasing Card Transactions

In the absence of Dr. Lilly, Ms. Takubo chaired the September 7, 2025 Executive / Management Committee meeting and provided today's report. Ms. Takubo reported that the Committee reviewed and approved the fiscal reports and purchasing card transactions for the months of June and July 2025. The Board continues to maintain a good financial position.

The motion of the Committee was given by Ms. Takubo, and the motion carried without opposition.

Consideration of an Inquiry Regarding the Use of Telehealth Pursuant to the Opioid Reduction Act

Ms. Takubo reported that the Opioid Reduction Act requires a practitioner to conduct and document the results of a physical examination every ninety days for any patient for whom he or she continues to treat with any scheduled II opioid drug. The Committee considered correspondence which inquired whether the required physical examination can be conducted remotely via telehealth. The Committee directed Board staff to refer the inquirer to the relevant statute, W. Va. Code § 16-54-1 *et seq.*, and recommend that they consult with legal counsel if they have any questions regarding interpretation or application of the statute.

Consideration of an Inquiry Regarding Delegation of Injections to Office Staff

Ms. Takubo reported that the Committee considered correspondence inquiring who can administer subcutaneous injections, such as GLP-1 and B12, in a health and wellness spa. The Committee directed Board staff to advise that the prescribing provider has the authority to delegate the administration of injections to staff who have the education, training and experience to safely perform such.

Consideration of an Inquiry Regarding Universal Professional and Occupational Licensing Act of 2025

Ms. Takubo reported that the Universal Professional and Occupational Licensing Act of 2025 (UPOLA) allows an individual to be granted a license, registration or certificate in West Virginia if they hold an equivalent credential in another state, in the same discipline and at the same practice level and meet all other requirements prescribed by law. As UPOLA does not define "state", the definition varies in other provisions of state code, and the West Virginia Medical Practice Act explicitly enumerates Puerto Rico along with the term state when provisions are applicable to both, the Committee directed Board staff to seek the opinion of the West Virginia Attorney General's Office with regard to this matter.

Consideration of a Request for Endorsement to Sit for United States Medical Licensing Examination

Prior to today's meeting, correspondence that was received from Leen Kayali, MD requesting sponsorship to sit for Step II of the United States Medical Licensing Examination (USMLE) and supporting documents were made available for members to review. Ms. Takubo reported that based upon the results of an investigation conducted by the USMLE Program's Committee for Individualized Review, Dr. Kayali was barred from taking Step II of the USMLE for a period of three years due to irregularities after her successful Step I attempt, which the USMLE considered to be the sharing of test material. The three-year bar elapsed in July 2025, and to sit for the Step II examination the USMLE requires Dr. Kayali to obtain endorsement from a medical licensing board. Based upon the information provided, the Committee recommended that the Board endorse Dr. Kayali to take the USMLE Step II examination. The motion of the Committee was given by Ms. Takubo, and the motion carried without opposition.

Litigation Matter

Ms. Takubo reported that in August 2025 the Board was served a Civil Summons in the matter of *Hil Rizvi, MD, Plaintiff, v. Mark Spangler, West Virginia Board of Medicine, Defendant*, Case No. 25-MISC-00285. This matter relates to Dr. Rizvi's application to reactivate a license to practice medicine and surgery in West Virginia. Anthony D. Eates, II, Esq. of the West Virginia Attorney General's Office represented the Board in this matter, which was dismissed on jurisdictional grounds.

Licensure Compact Update

Ms. Takubo reported that the Committee received an update from staff regarding licensure compacts.

The Interstate Medical Licensure Compact (IMLC) continues to expand. There are currently forty-four states participating in the compact. The IMLC Commission is scheduled to meet on November 17-18, 2025 in Denver, Colorado.

The Interstate Podiatric Medical Compact (IPMC) is starting to be introduced in legislatures throughout the country. West Virginia may seek introduction of IPMC legislation in 2027.

An update regarding the Physician Assistant Compact will be provided later this morning as part of the Physician Assistant Committee Report.

Update Regarding Technology Upgrades

Ms. Takubo reported that Board staff are currently obtaining quotes for technology upgrades to the boardroom and the conference room. It is anticipated that a vendor will be selected in the coming weeks, and that installation will commence soon thereafter.

Update Regarding Procurement of a New Database and Website

Ms. Takubo reported that Board staff continue to work with the West Virginia Purchasing Division to procure a new database. The Request for Proposal has been published, and vendor questions have been submitted to the Board for response. The Board remains in what the Purchasing Division refers to as a “Blackout Period” which prohibits the Board from engaging in conversation with any potential database vendor.

Acceptance and Ratification of Report

The Committee recommended that the Board accept and ratify the Executive / Management Committee Report. The motion of the Committee was given by Ms. Takubo, and the motion carried without opposition.

Legislative Committee Report

Board of Medicine Rules

Dr. Challa reported that the Legislative Committee met yesterday, September 7, 2025, at which time Mr. Spangler reported that the Agency Approved version of W. Va. Code § 11-1B-1 *et seq.*, *Licensure, Practice Requirements, Disciplinary and Complaint Procedures, Continuing Education, Physician Assistants*, and W. Va. Code § 11-6-1 *et seq.*, *Continuing Education Requirements for Physicians and Podiatric Physicians*, have been filed with the West Virginia Secretary of State’s Office and will be considered by the West Virginia Legislature during the 2026 legislative session. The amendments to these rules update the continuing education requirements for medical doctors, podiatric physicians and physician assistants to require that a 3-hour board approved course on risk assessment and responsible prescribing of controlled substances training be completed within one year of being granted an initial license. The course will no longer be required as a prerequisite for license renewal.

Additional proposed amendments to W. Va. Code § 11-1B-1 *et seq.* reflect the National Commission on Certification of Physician Assistants two different recertification processes, and clarifies that either process, if completed during the relevant reporting period, may be used to satisfy a physician assistants continuing education requirements.

Also, additional proposed amendments to W. Va. Code § 11-6-1 *et seq.* updates nomenclature as it relates to continuing certification processes for physicians who are board certified by an American Board of Medical Specialties member board.

Potential 2026 Legislative Topics

Dr. Challa reported that in preparation for the 2026 legislative session, the Committee asked Board staff to explore development of an emeritus / retirement license and alternate licensing models for international medical graduates. Board staff will present concepts and make recommendations to the Committee at a future meeting.

Acceptance and Ratification of Report

The Committee recommended that the Board accept and ratify the Legislative Committee Report. The motion of the Committee was given by Dr. Challa, and the motion carried without opposition.

W. Va. Code § 30-3-14(f) provides as follows: "The investigating body (Complaint Committee) ... may request and the board under any circumstances may require a physician ... to submit to a physical and mental examination, by a physician or physicians approved by the board."

In connection with its current investigation, and pursuant to West Virginia Code § 30-3-14(f), the Complaint Committee requests that the Board authorize the issuance of an Order requiring the subject physician to submit to a complete mental and physical examination by a physician or physicians approved by the Board.

Ms. Mayfield advised that Mr. Foster is available to answer any questions that members may have regarding this process. No questions were asked.


