With no conflicts declared, **Mr. Wooton** moved that the Committee approve the list of initial medical licensure applicants and the listed podiatric physician. **Mr. Wooton** further moved that the Committee recommend that the Board grant each applicant the requested license. **Ms. Takubo** seconded the motion, and the motion carried.

Request to Convert License

The Committee received correspondence from medical school faculty licensee Federico Gian Filippo Seifarth, MD seeking an unrestricted license, or in the alternative the ability to broaden his practice beyond the medical center of his medical school of faculty appointment. The Committee engaged in a careful review of his correspondence, practice credentials and curriculum vitae. Thereafter, **Ms. Takubo** moved that the Committee direct staff to reach out to Dr. Seifarth and invite him to request the conversion of his medical school faculty license to an application for a restricted license issued in extraordinary circumstances, which could permit the licensee to practice pediatric surgery throughout the state. **Mr. Wooton** seconded the motion and the motion carried.
