???DID YOU KNOW???

The **Health Insurance Portability and Accountability Act (HIPAA)** permits the imposition of reasonable, cost based fees by health care providers when patients request copies of their medical records. The fee may include only the cost of copying (including supplies and labor) and postage.

However, West Virginia state law requirements (<u>West Virginia Code</u> §16-29-2) state reasonable expenses are to be reimbursed as follows:

The health care provider shall be reimbursed by the person requesting in writing a copy of the records at the time of delivery for all reasonable expenses incurred in producing record copies: "Provided, That the cost may not exceed seventy-five cents per page for the copying of any record or records which have already been reduced to written form and a search fee may not exceed ten dollars."

A provider shall not impose a charge on an indigent person or his or her authorized representative if the medical records are necessary for the purpose of supporting a claim or appeal under any provisions of the Social Security Act.

The state law further provides that: *a person is considered indigent if he or she:*

Is represented by an organization or affiliated pro bono program that provides legal assistance to indigents; or

Verifies on a medical records request and release form that the records are requested for purposes of supporting a social security claim or appeal and submits with the release form reasonable proof that the person is financially unable to pay full copying charges by reason of unemployment, disability, income below the federal poverty level, or receipt of state or federal income assistance.

Any person requesting free copies of written medical records is limited to one set of copies per provider. Additional requests for the same records from the same provider are subject to the fee provisions.

The search fee allowed under West Virginia law is preempted or voided by **HIPAA** and only the copying fee, not to exceed \$.75 per page, may be imposed.

MEDICAL DOCTOR/PODIATRIST/PHYSICIAN ASSISTANT SEARCH NOW ON WEB SITE

In September, 2005, the West Virginia Board of Medicine launched a Medical Doctor/Podiatrist/Physician Assistant Search option on the Board's web site. This feature will allow anyone to search for a medical doctor, podiatrist, or physician assistant by name, license number, license type, specialty, or work location. The Search will display data such as: directory information and disciplinary information.

The web site also has information on medical corporations and professional limited liability corporations.

REMINDERS

DISCHARGE OF A PATIENT

If you are discharging a patient from your practice, the Board recommends giving at least thirty (30) days notice to the patient, in writing, with an explanation that if an emergency arises within the thirty (30) day period where first aid treatment is essential, you will respond to the best of your ability to care for the patient at that time. This is based on the opinion of the AMA on Neglect of Patients in its Council on Ethical and Judicial Affairs Code of Medical Ethics. The book may be obtained by calling the AMA toll free at 800.621.8335.

The AMA's Council on Ethical and Judicial Affairs Code of Medical Ethics also contains a number of helpful opinions on physician records, including one on Records of Physicians Upon Retirement or Departure from a Group and on the Sale of a Medical Practice. The Board recommends that patients be notified about what is happening to their records in each of the above situations, and given an opportunity to have the records forwarded to the physician of their choice. We recommend especially that you obtain your own copy of the Code of Medical Ethics so that you are able to review these opinions, and many others on a wide variety of topics, for yourself.

TOLL-FREE NUMBER FOR CONSUMER COMPLAINTS

The Board has a toll-free number for callers within West Virginia who have consumer complaints against an M.D., D.P.M., or P.A.-C. The toll-free number is 877.867.6411. For all matters other than consumer complaints, the Board's main number, 304.558.2921, must be used.

ADDRESS OF A LICENSEE IS PUBLIC INFORMATION

West Virginia Legislative Rule 11 CSR 1A 10.2(a) requires the West Virginia Board of Medicine to provide, upon written or verbal request, an address of a medical doctor, podiatrist, or physician assistant. Recently, all information pertaining to licensed medical doctors, podiatrists, and physician assistants became available to the public by access to the Board of Medicine's Internet Website. With the release of this information, it has highlighted the need for licensees to carefully consider the address provided to the Board as the preferred address of record. Please be aware that the address the licensee indicates as his or her preferred address of record will be the address disclosed to all individuals making inquiries and will be utilized to mail all licenses, renewal applications, and other official correspondence from the West Virginia Board of Medicine. Licensees have the option to choose their home address or their principal office address as their preferred address of record. It is the responsibility of the licensee to inform the Board of the licensee's correct address and of any change of address. The Division of Motor Vehicles may require the person to submit to relevant examinations, then, if appropriate, the license may be revoked, suspended or restricted.

Board Action: Shall successfully complete a course in "Controlled Substance Management" and a course in record keeping, within ten (10) months of the date of entry of the Consent Order; agrees to cease advising patients to cut time-released medications in half with a pill cutter; shall continue to reduce the number of patients he examines or otherwise treats in a given day; and shall not examine more than twenty-five (25) patients in a twenty-four (24) hour period, excluding those patients Dr. Derakhshan visits or otherwise treats in any hospital.

DIAL, WALTER EVERETT, M.D. – Ranger, WV (08/04/2005)

Board Conclusion: Relating to unprofessional and unethical conduct.
